2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE
3 CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE A
4 STANDARD AGREEMENT CONTRACT WITH THE CALIFORNIA
5 DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL FOR THE
6 ALCOHOL POLICING PARTNERSHIP PROGRAM (APP) AND ACCEPT
7 A GRANT AWARD IN THE AMOUNT OF \$98,343.00 TO INCREASE
8 ENFORCEMENT ACTIVITY AND COMBAT ALCOHOL-RELATED
9 CRIMES IN RELATION TO ALCOHOLIC BEVERAGE CONTROL
10 VIOLATIONS FOR THE PERIOD OF JULY 1, 2023, THROUGH JUNE 30,
11 2024.

12 WHEREAS, the City of Riverside, by and through the Riverside Police Department (“RPD”),
13 desires to increase enforcement activity and combat alcohol-related crimes in relation to alcoholic
14 beverage control in collaboration with the Department of Alcoholic Beverage Control investigators,
15 to be funded in part from funds in the amount of \$98,343.00, made available through the Alcohol
16 Policing Partnership Program (APP) administered by the Department of Alcoholic Beverage Control
17 (“ABC”).

18 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
19 California, as follows:

20 Section 1: That the City Manager of the City of Riverside, or his or her designee, is authorized
21 to execute on behalf of the City Council the Standard Agreement contract (“Contract”) which is hereto
22 attached as Attachment “A”, and any extensions or amendments thereof and any subsequent contract
23 with the State of California in relation thereto.

24 Section 2: Any liability arising out of the performance of the Contract, including civil court
25 actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The
26 State of California and ABC disclaim responsibility for any such liability.

27 Section 3: That grant funds in the amount of \$98,343.00 be received hereunder, shall not be
28 used to supplant expenditures controlled by this body.

Section 4: This award shall not be subject to local hiring freezes.
