A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE MASTER PARKING SCHEDULE RESOLUTION TO REMOVE A SEGMENT OF THE EXISTING 1-HOUR PARKING ZONE AND ESTABLISH PREFERENTIAL PARKING ZONES ON DESIGNATED SEGMENTS OF BANDINI AVENUE WEST OF OLIVEWOOD AVENUE

WHEREAS, the Public Works Department received a petition from 83% of residents on Bandini Avenue from Olivewood Avenue to 350 feet westerly thereof requesting removal of the existing 1-Hour Parking Zone on both sides of the street from Olivewood Avenue to Osburn Place and establishment of Preferential Parking Zones (PPZ's) on the south side of the street from Olivewood Avenue to Osburn Place and on the north side from Olivewood Avenue to 350 feet westerly thereof; and

WHEREAS, residents indicate that overflow parking from nearby apartment complexes is limiting on-street parking opportunities for residents and their guests and that the existing 1-Hour Parking Zone no longer meets resident's needs; and

WHEREAS, on December 2, 2015, the Transportation Board ("Board") denied the proposal to remove the existing "1-Hour Parking Zone between the hours of 9:00 a.m. to 6:00 p.m. of any day except Sunday and holidays" Zone on both sides of Bandini Avenue from Olivewood Avenue to Osburn Place and to establish the proposed "No Parking Any Time, with Preferential Permit Parking for residents" Zones on the south side of Bandini Avenue from Olivewood Avenue to Osburn Place and on the north side of Bandini Avenue from Olivewood Avenue to Osburn Place and on the north side of Bandini Avenue from Olivewood Avenue to 350 feet westerly thereof. Though the Board did not recommend removal of the existing 1-Hour Parking Zone on both sides of Bandini Avenue from Olivewood Avenue to Osburn Place and establishment of the proposed PPZ's, minimum petition criteria was exceeded showing strong neighborhood support for removal of the existing 1-Hour Parking Zone and creation of the PPZ's; and

WHEREAS, the Public Works Department has reviewed the request and advocated both removal of the existing 1-Hour Parking Zone and establishment of the PPZ's on Bandini Avenue as originally proposed to better serve the current needs of the residents by restricting outside

1	parking sources and providing residents and their guests with reasonable access to on-street
2	parking at all times.
3	NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
4	California, as follows:
5	Section 1: The recitals set forth above are incorporated herein by reference.
6	Section 2: That the Master Parking Schedule is hereby amended by a) removing the
7	existing "1-Hour Parking Zone between the hours of 9:00 a.m. to 6:00 p.m. of any day except
8	Sunday and holidays" Zone on both sides of Bandini Avenue from Olivewood Avenue to Osburn
9	Place; and b) establishing "No Parking Any Time, with Preferential Permit Parking for residents"
10	Zones on the south side of Bandini Avenue from Olivewood Avenue to Osburn Place and on the
11	north side of Bandini Avenue from Olivewood Avenue to 350 feet westerly thereof
12	Section 3: That the provisions of this resolution shall be operative only when signs are
13	erected on that portion of the street set forth in Section 2 above, giving notice of the parking
14	limitations or prohibitions herein established.
15	Section 4: The provisions of this amendment shall be operative as of the date of adoption
16	of this resolution.
