Following discussion and without formal motion, the City Council received and ordered filed a presentation of the General Services Department core functions and staff accomplishments.

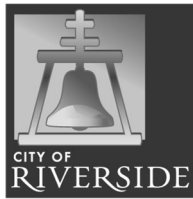

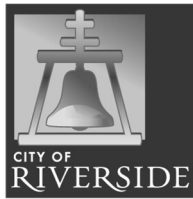

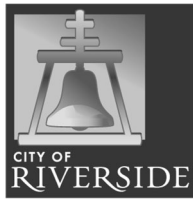

REQUEST FOR PROPOSAL 2233 - AGREEMENT - INVESTMENT MANAGEMENT SERVICES

The City Council (1) approved a Professional Consultant Services Agreement from Request for Proposal No. 2233 for Investment Management Services with Chandler Asset Management, Inc., San Diego, for \$350,000 annually for a three-year term with two optional one-year extensions, for a total contract amount of \$1,750,000; and (2) authorized the City Manager, or designee, to execute the Professional Consultant Services Agreement, including making minor and non-substantive changes and executing the optional contract extensions.

CALIFORNIA FIRE FIGHTER JOINT APPRENTICESHIP COMMITTEE REIMBURSEMENT - FIRE TRAINING SUPPORT - SUPPLEMENTAL APPROPRIATION

The City Council (1) authorized acceptance of training reimbursement funds from California Fire Fighter Joint Apprenticeship Committee in the amount of \$60,000; and (2) with at least five affirmative votes, authorized the Chief Financial Officer, or his designee, to record an increase in revenue and appropriate expenditures in an equal amount in the Grants and Restricted Programs Fund, California Fire Fighter Joint Apprenticeship Committee accounts.

BID 7941 - CHECK POINT FIREWALL REPLACEMENT

The City Council (1) awarded Bid 7941 for the purchase of the Check Point Firewall replacement and year two of annual maintenance and support to Novacoast, Inc., in the amount of \$363,019.24 in accordance with existing Service Level Agreement with Check Point Software Technologies, Inc.; and (2) authorized the City Manager, or designee, to execute documentation to effectuate and enforce this purchase, including making minor and non-substantive changes.

CALIFORNIA STATE LIBRARY GRANT - FISCAL YEAR 2022-23 ADULT AND FAMILY LITERACY PROGRAMS - SUPPLEMENTAL APPROPRIATION

The City Council (1) approved the acceptance of grant funds from the California State Library for adult and family literacy programs for Fiscal Year 2022-23 in the amount of \$49,731, plus an estimated final installment amount of \$2,726, based on the per capita of

The City Council (1) adopted a Resolution authorizing the City Manager, or designee, to accept awarded grant funds and execute any and all agreements and award documents on behalf of the Riverside Public Library for the California State Library Building Budget Act of 2021 (SB) Forward Library Infrastructure Grant Program in the amount of \$51,406 with a 50 percent City match commitment of \$25,704 from General Services, Measure Z Annual Deferred Maintenance; and (2) with at least five affirmative votes, authorized the Finance Department to record an increase in estimated revenue in the amount of \$51,406 and appropriate expenditures in the same amount in designated project accounts; whereupon, the title having been read and further reading waived, Resolution No. 23926 of the City Council of the City of Riverside, California, Authorizing the City of Riverside to Receive Grant Funds from the California State Library Budget Act of 2021 (SB 129) Building Forward Grant Program for Life Safety Improvements to the Orange Terrace, Arlington, and Arlanza Branch Libraries, in an Amount Not to Exceed \$51,406 with a 50% City Match Commitment of \$25,704 From General Services, Measure Z Annual Deferred Maintenance Funds: and Authorizing the Execution of Necessary Grant Documents by the City Manager or his Designee, was presented and adopted.

MEASURE Z - MOUNT RUBIDOUX TRAIL IMPROVEMENTS PROJECT

Following discussion, it was moved by Councilwoman Plascencia and seconded by Councilmember Edwards to approve the Financial Performance and Budget Committee recommendation to (1) receive a report from California Strategies, LLC, regarding the Riverside Transmission Reliability Project (RTRP) analysis; and (2) direct staff to continue to work collaboratively with Southern California Edison on the project as previously approved by the City Council and the California Public Utilities Commission.

Following further discussion, a substitute motion was made by Councilmember Hemenway and seconded by Councilmember Cervantes to approve the Financial Performance and Budget Committee recommendation to (1) receive a report from California Strategies, LLC, regarding the Riverside Transmission Reliability Project (RTRP) analysis; and (2) adopt a Resolution in support of further undergrounding of RTRP and implementation of the Action Plan in California Strategies' report. The motion failed with Councilmembers Cervantes, Fierro, and Hemenway voting aye, and Councilmembers Edwards, Conder, Perry, and Councilwoman Plascencia voting no.
