PLANNING CASE PR-2022-001321 – MODIFICATION OF CONDITIONS (P14-0839) – 3422
RUSTIN AVENUE, WARD 1

Proposal by Dr. Virgie Rentie of Reach Leadership STEEAM Academy to consider a Modification of Conditions to delete condition of approval #4 related to previously approved Conditional Use Permit (P14-0839) for the operation of a temporary charter school (Kindergarten – 6th grade). Regine Osorio, Associate Planner, presented the staff report. Commissioner Ridgway joined the meeting at this time. Virgie Rentie, stated they were in agreement with the recommended conditions of approval. There were no public Comments and the public hearing was closed.
