### CONSENT CALENDAR

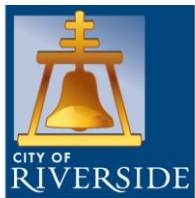

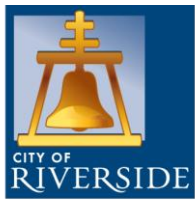
