

SECOND AMENDMENT TO
PROFESSIONAL CONSULTANT SERVICES AGREEMENT

BABCOCK LABORATORIES, INC.
[Laboratory Testing and Analytical Services; RFP No. 1794]

THIS SECOND AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("Second Amendment") is made and entered into this 30th day of July, 2021, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and BABCOCK LABORATORIES, INC., a California corporation ("Consultant"), with respect to the following:

RECITALS

A. The City and Consultant entered into that certain Professional Consultant Services Agreement dated June 20, 2018 ("Agreement") for Laboratory Testing and Analytical Services; RFP No. 1794 ("Project").

B. The initial term of agreement was three years, ending on June 30, 2021. The Agreement included the option to extend the term of the Agreement for up to two additional one-year periods.

C. The City and Consultant entered into the First Amendment to Professional Consultant Services Agreement ("Agreement"), dated March 19, 2021, to extend the term of the agreement to June 30, 2022 with additional compensation in the amount of Five Hundred Ninety-Six Thousand Five Hundred Ninety-One Dollars (\$596,591).

D. The City and Consultant desire to amend the Agreement for additional services in the amount not to exceed One Hundred and Fifty Thousand Dollars (\$150,000), for services incurred prior to June 30, 2021.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

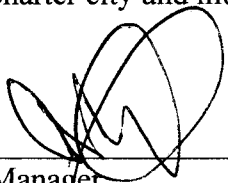
1. Section 3, "Compensation/Payment," is hereby amended to increase the compensation by an amount not to exceed One Hundred Fifty Thousand Dollars (\$150,000) for the initial term of the Agreement.

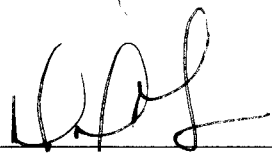
2. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Second Amendment, shall remain in full force and effect as if fully set forth herein.

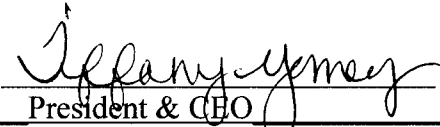

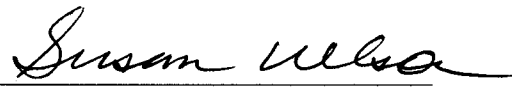
