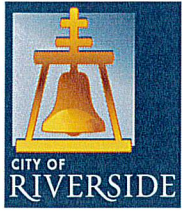

#### DISCUSSION CALENDAR

CEREMONIAL DEDICATION OF PRICE COURT TO WINEK COURT IN HONOR OF WINEK FAMILY  
Following discussion, it was moved by Member Perry and seconded by Vice Chair Hemenway to (1) receive and order filed the report on the ceremonial dedication of Price Court to Winek Court; and (2) recommend that the City Council (a) receive the report on the ceremonial dedication of Price Court to Winek Court; (b) direct the City Attorney to draft a resolution; and (c) approve the planned funding source through the Public Works Department. The motion carried unanimously.

NEIGHBORHOOD TRAFFIC MANAGEMENT PROGRAM (NTMP) - REINSTATE USE OF SPEED HUMPS - ESTABLISH NEW TEMPORARY ART CROSSWALK AND PAVEMENT MURAL PILOT PROGRAMS

Following discussion, it was moved by Member Perry and seconded by Vice Chair Hemenway to recommend that the City Council consider the proposed revisions to the Neighborhood Traffic Management Program (NTMP) including the (1) reinstatement of speed humps as a local street secondary mitigation measure option under the NTMP with modifications to the "Traffic Conditions" qualifying criteria; and (2) establishment of a new Temporary Art Crosswalk and Pavement Mural Pilot Program as a local street secondary mitigation measure option under the NTMP. The motion carried unanimously.

#### PROJECT UPDATES

Public Works Deputy Director Nathan Mustafa provided updates regarding the (1) recruitment for a Deputy Public Works Director Field Operations position; (2) Citywide Traffic Signal Controller Replacement Project; (3) Citywide Pedestrian Crossing Project; (4) Park System - Parking, Access, and Revenue Control System has completed its installation; (5) use of new trash cans in Downtown area; and (6) release of two new videos were posted on social media for the Solid Waste Division; the videos are "A Day in the Life" of manual and automated refuse crews.

Public Works Director Gil Hernandez provided updates including (1) the issuance of a Request for Proposals to conduct a Pavement Trench Cut Fee Study; (2) the collaboration of the Marketing Division and Parks and Recreation regarding "Revitalize Riverside" which will detail and post active projects on the City's website; and (3) an upcoming meeting regarding Fiscal Year 2023-24 Paving and Traffic Engineering projects.
