ALESSANDRO ARROYO Hearing was called to consider the appeal by Jim Guthrie, Friends of Riverside's Hills, and Robert and Susan Burton of the decision of the Planning Commission in approving Tract Map 31930 to subdivide approximately 86.31 vacant acres into 29 residential and five open space lots located southerly of the terminus of Cresthaven Drive and northerly of Alessandro Arroyo in Zones RC and O. Eight people spoke regarding the matter. Two letters were presented and considered. Following discussion, the public hearing was officially closed. The City Council (1) upheld the decision of the Planning Commission in approving Case P03-1451 subject to conditions; (2) adopted the staff report and environmental assessment as finding; (3) determined that the project would not have a significant effect on the environment because of the mitigation measures described in the staff report and adopted a Mitigated Negative Declaration; (4) found there is no evidence that the proposed project will have any adverse effect on wildlife resources and the impacts of the project are found to be de minimis pursuant to Section 711.4 of the Fish and Game Code; and (5) requested the City Attorney's Office prepare a resolution setting forth the findings in support of the Mitigated Negative Declaration and adopting a Mitigation Monitoring Program.
