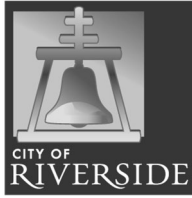
Councilmember Cervantes requested to attend the meeting virtually pursuant to Assembly Bill 2449 under the provision of 'Emergency Circumstances.'

MEMORANDUM OF UNDERSTANDING - FRINGE BENEFITS AND SALARY PLAN AMENDMENT - RESOLUTION

The City Council (1) approved a three-year Memoranda of Understanding (MOU) effective January 1, 2025, through December 31, 2027, with Riverside Police Officer's Association (RPOA) and RPOA Supervisory Units which incorporate the negotiated revisions, and authorize the City Manager, or designee, to execute the Memoranda of Understanding on behalf of the City; (2) adopted a Resolution amending the Master Fringe Benefits and Salary Plan to reflect the revised MOU provisions as outlined in the staff report; and (3) authorized the Chief Financial Officer, or designee, to record supplemental appropriations in the approximate amounts of \$1.20 million in Fiscal Year 2024-25 in the applicable funds and accounts; whereupon the title having been read and further reading waived, Resolution No. 24209 of the City Council of the City of Riverside, California, Amending Resolution No. 21052 to Amend Parts I and II of the Fringe Benefits and Salary Plan, to Reflect Various Updates and Changes in Connection with the Memoranda of Understanding with the Riverside Police Officer's Association (RPOA) and the Riverside Police Officer's Association (RPOA) Supervisory Units; and to Approve the Creation of the New Classification and Salary Range for the Chief Pilot, was presented and adopted.

PURCHASE - MICROSOFT SOFTWARE LICENSES, PRODUCTS AND SERVICES

The City Council (1) approved the purchase of Microsoft software licenses, products and services through Dell Marketing, L.P., for a three-year term in the amount of \$3,834,925.35; (2) authorized staff to issue change orders in an amount not-to-exceed 15 percent of the total contract amount, allowing for additional purchases not exceeding \$575,239 for a total contract amount of \$4,410,165; and (3) authorized the City Manager, or designee, to execute all documents necessary to effectuate this Addendum, optional extensions, and amendments to add-on additional licenses, as well as making minor and non-substantive changes.

REVISED PURCHASE ORDER 251896 - LIBRARY MATERIALS AND SERVICES

The City Council (1) approved and authorized an increase of Purchase Order 251896 with Midwest Tape, LLC, Holland, Ohio, in the amount of \$40,000 for the purchase of library materials and services for a revised purchase order amount of \$100,000 with automatic annual renewal; (2) authorized the increase from \$60,000 to \$100,000 annually for the term of the contract for a total contract amount of \$160,000; and (3) authorized the City

DEACCESSION - MEIER COLLECTION - MUSEUM OF RIVERSIDE'S PERMANENT COLLECTION
The City Council approved deaccession from the permanent collection of 373 objects from the Meier collection, including 193 books and magazines, 79 documents, 27 photographs and prints, 20 household utensils, 13 household objects, 4 personal objects, 4 recreational objects, 31 tools, and 2 miscellaneous objects.

BID 8110 - CHANGE ORDER AUTHORITY - NICHOLS PARK PLAYGROUND, SHADE STRUCTURE, AND RESILIENT SURFACING INSTALLATION PROJECT - SUPPLEMENTAL APPROPRIATIONS - 5505 DEWEY

The City Council (1) awarded Bid 8110 to ZECO Inc., Santa Ana, in the amount of \$213,500.00 for the Nichols Park Playground, Shade Structure, and Resilient Surfacing Installation Project; (2) authorized 25 percent change order authority in an amount up to \$53,375 for project changes including, but not limited to, unforeseen conditions or necessary design changes, for a total contract amount not-to-exceed \$266,875; (3) authorized the Chief Financial Officer, or designee, to record all necessary supplemental appropriations and interfund transfers in the amount of \$245,525 from General Fund unexpended and unobligated ARPA funds to the Capital Outlay Fund, Nichols Park Project; and (4) authorized the City Manager, or designee, to execute a Construction Agreement with ZECO Inc., Santa Ana, including making minor and non-substantive changes.

MEMORANDUM OF UNDERSTANDING - FISCAL YEAR 2024-25 PUBLIC SAFETY REALIGNMENT REIMBURSEMENT OF PERSONNEL, VEHICLE, AND OPERATION AND MAINTENANCE COSTS - SUPPLEMENTAL APPROPRIATION

The City Council (1) approved the Memorandum of Understanding between the Riverside County Probation Department and Post-Release Accountability and Compliance Team for reimbursement of personnel, vehicle, and operation and maintenance costs related to Public Safety Realignment for Fiscal Year 2024-25; (2) authorized the acceptance of additional funding from Riverside County Probation Department in the amount of \$138,150 for vehicle and operation and maintenance expenditures related to Public Safety Realignment for the total amount of \$535,150 for Fiscal Year 2024-25; (3) authorized the Chief Financial Officer, or designee, to record an increase in revenue in the amount of \$138,150 and appropriate an equal amount of expenditures in the General Fund, Special Operations revenue and expenditure

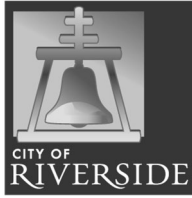

PUBLIC HEARING

2023-2024 UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT - ANNUAL ACTION PLAN AMENDMENT - RIVERSIDE ACCESS CENTER RENOVATION PROJECT - SUPPLEMENTAL APPROPRIATION - FUNDS TRANSFER - 2880 HULEN PLACE

Public Hearing was called to consider an amendment to the City of Riverside Fiscal Year 2023-2024 United States Department of Housing and Urban Development Annual Action Plan to allocate \$400,695 of Community Development Block Grant Unprogrammed Funds to the Riverside Access Center renovation project located at 2880 Hulen Place and approve a Design/Build Agreement with Cal-City Construction Inc., Cerritos, from Request for Proposals 2381 for design services and construction for the Riverside Access Center renovation project in the amount of \$1,339,000 plus a 15 percent contingency in the amount of \$200,850 for a total not-to-exceed the amount of \$1,539,850. No one spoke regarding the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Conder and seconded by Councilmember Mill to (1) authorize an amendment to the City of Riverside Fiscal Year 2023-2024 United States Department of Housing and Urban Development Annual Action Plan to allocate \$400,695 of Community Development Block Grant Unprogrammed Funds to the Riverside Access Center renovation project located at 2880 Hulen Place; (2) authorize a transfer in the amount of \$400,695 within the Community Development Block Grant Fund Unprogrammed Funds account to the Riverside Access Center Rehabilitation Project account; (3) authorize the City Manager, or his designee, to execute a First Amendment to a Memorandum of Understanding with the Department of Housing and Human Services for an additional allocation of \$400,695 of Community Development Block Grant funds for the 2023-2024 Riverside Access Center Renovation Project, including making minor non-substantive changes, and to sign all documents and instruments necessary to implement this action; (4) authorize the Chief Financial Officer, or designee, to record a supplemental appropriation of \$400,695 in the Grants and Restricted Programs Fund 23-24 Riverside Access Center Rehabilitation account, and a supplemental appropriation in the same amount to the inter-fund account for reimbursement of CDBG-related expenditures; (5) approve a Design/Build Agreement with Cal-City Construction, Inc., Cerritos, from Request for Proposal 2381 for design services and construction for the Riverside Place Access Center renovation project in the

amount of \$1,339,000; (6) approve a 15 percent contingency change order authority in the amount of \$200,850 for a total not-to-exceed amount of \$1,539,850; and (7) authorize the City Manager, or designee, to execute the Design-Build Agreement including making minor, and non-substantive changes. The motion carried unanimously.

MAYOR AND CITY COUNCIL COMPENSATION - SALARY AND FRINGE BENEFITS - ORDINANCES INTRODUCED

Public Hearing was called to determine whether to increase compensation for the Mayor and Members of the City Council not exceeding 5 percent of the current salary. One person spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Robillard and seconded by Councilmember Falcone to (1) increase the compensation for the Mayor and Members of the City Council five (5%) percent of the current salary; (2) introduce an ordinance establishing the level of compensation of the Mayor and providing certain fringe benefits, and repealing Ordinance No. 7626 in its entirety; (3) introduce an ordinance establishing the level of compensation for Members of the City Council and providing certain fringe benefits, and repealing Ordinance No. 7627 in its entirety. The motion carried with Councilmembers Falcone, Cervantes, Robillard, Mill, and Hemenway voting aye and Councilmembers Conder and Perry voting no.

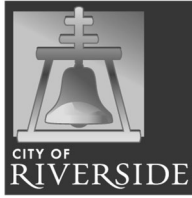
