

## SECOND AMENDMENT TO SERVICES AGREEMENT

### WASH MASTER LLC

#### Citywide Car Wash Services

This SECOND AMENDMENT TO SERVICES AGREEMENT (“Second Amendment”) is made and entered into this 27 day of MARCH, 2024, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and WASH MASTER LLC, a California limited liability company (“Contractor”).

#### RECITALS

WHEREAS, on February 28, 2023, City and Contractor entered into a Services Agreement for Citywide Car Wash Services (“Agreement”); and

WHEREAS, on April 3, 2023, City and Contractor entered into a First Amendment to Services Agreement (“First Amendment”) to incorporate Exhibits “A,” “B,” and “C,” which were omitted from the original Services Agreement; and

WHEREAS, the Agreement is set to expire February 28, 2024; and

WHEREAS, City and Contractor would like to extend the term of the Agreement for one year, to February 27, 2025; and

WHEREAS, City and Contractor desire to increase the Compensation to One Hundred Seventy-Two Thousand Six Hundred Sixty-Four Dollars and Twenty-Eight Cents (\$172,664.28), with a fifteen percent (15%) change order authority, for total amount not to exceed One Hundred Ninety-Eight Thousand Five Hundred Sixty-Three Dollars and Ninety-Two Cents (\$198,563.92) annually, for the extended Term of the Agreement.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Contractor agree as follows:

1. Section 2, Term, of the Agreement is hereby extended for one year, to February 27, 2025.
2. Section 3, Compensation, of the Agreement is hereby increased to One Hundred Seventy-Two Thousand Six Hundred Sixty-Four Dollars and Twenty-Eight Cents (\$172,664.28), with a fifteen percent (15%) change order authority, for total amount not to exceed One Hundred Ninety-Eight Thousand Five Hundred Sixty-Three Dollars and Ninety-Two Cents (\$198,563.92) annually, for the extended Term of the Agreement.
3. All terms and conditions of the original Agreement not inconsistent with this Second Amendment shall remain in full force and effect and are incorporated herein by this reference as though set forth in full.
