BACKGROUND

Short-term rentals (STRs) defined in the Riverside Municipal Code (19.910.200) and regulated in Title 5.

"The rental of a dwelling, or a portion thereof, by the owner to another person or group of persons for occupancy, dwelling, lodging or sleeping purposes for a period of less than 30 consecutive calendar days. The rental of units within city-approved hotels, motels, and bed-and-breakfast inns shall not be considered to be a short-term rental."

DISCUSSION

- 1. 10/2018: Council approved VCA for Airbnb to collect Transient Occupancy Tax (TOT).
- 2. 5/2019: Airbnb amended VCA requiring City to ensure collection enforcement of TOT.
- 3. 11/2020: City terminated VCA and contracted with HdL to provide TOT Management and STR services.
 - During transition process City collected TOT.
- 4. 7/2021: HdL started STR services and collection of TOT.

AIRDNA DATA VS. HdL DATA

AirDNA	HdL
Data inflated due to tracking listings that may be advertised on multiple online platforms.	Data is tracked by property.
Data may not filter out STR's over 30 days.	Data is filtered to only include 30 days or less as defined by RMC.
Self-reporting aspect is solely at discretion of renter (advertising entire home on one platform vs. private room on another).	

Data can be very fluid as homeowners have discretion to list and remove advertisements on any given month.

Comprehensive STR platform by Deckard Technologies. Identifies, tracks, and reports STR registrations, booking activities, licenses, and TOT.


