The downtown valet service will operate in designated on-street zones and within alleyways established and approved by the Traffic Engineering and Parking Services Divisions. CHALLEN AVENUE AT ORLANDO DRIVE & FOOTHILL AVENUE – PROPOSED REMOVAL OF TEMPORARY NEIGHBORHOOD TRAFFIC CIRCLE PILOT PROJECT MATERIALS AND INSTALL PERMANENT IMPROVEMENTS

At the conclusion of all pilot project assessments and the support of the community, the Public Works Department recommends the removal of the temporary pilot project improvements and supports the construction of the permanent improvements to install a neighborhood traffic circle at the intersection of Challen Avenue and Orlando Drive / Foothill Avenue. The Traffic Engineering Division is working to prepare the street improvement plans and will plan to include the permanent improvements as part of the upcoming Capital Improvement Project (CIP) for 2024-25 paving projects. No Ecomments were received. One person spoke in support. There were no callers.

DOWNTOWN PARKING HOURS CHANGES UPDATE

CITY COUNCIL ACTIONS ON TRAFFIC ENGINEERING-RELATED ITEMS

- a. On May 7th, the City Council approved reinstating Speed Humps as part of the Neighborhood Traffic Management Program.
- b. On May 21st, at the City Council meeting, a grant application was presented for the "Safe Streets for All Program" 2024 for Wards 3, 6, and 7, asking for funding for bike lanes, high-visibility crosswalks, audible pedestrian push buttons, sidewalk improvements, and traffic-calming improvements.
- c. As Part of that same grant application, we also submitted a request for a Citywide Intelligent Transportation System Master Plan (ITS Master Plan). This ITS Master Plan will help connect and communicate with all our signals.
