FISCAL YEAR 2023/2024 CITY SPONSORSHIP PROGRAM JANUARY 1 - JUNE 30, 2024

Following discussion, it was moved by Member Hemenway and seconded by Vice Chair Edwards to (1) receive and approve staff recommendations for the City Sponsorship Program for the six-month period of January 1 – June 30, 2024; (2) recommend that City Council approve City Sponsorship support in the form of monetary funding and/or in-kind contributions of \$199,616 for charitable and community events, which are produced by local non-profit organizations; and (3) receive and ordered filed the Table of Sponsorship report for January 1 – June 30, 2023. The motion carried unanimously.

NAMING RIGHTS SPONSORSHIP ASSET INVENTORY AND VALUATION REPORT BY SUPERLATIVE GROUP, INC

Following discussion, it was moved by Member Hemenway and seconded by Vice Chair Edwards to (1) receive and ordered filed report on Phase 1 Sponsorship Asset Inventory and Valuation for potential naming rights of Riverside municipal buildings and other assets; (2) move forward to Phase 2, outreach and sales of naming rights and return to Committee to present agreements and make recommendation to forward to council. The motion carried unanimously.
