

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO. 24131
4 TO AMEND THE TWO-YEAR BUDGET OF THE CITY OF
5 RIVERSIDE FOR THE FISCAL YEAR BEGINNING JULY 1, 2025,
6 AND ENDING JUNE 30, 2026.

7 WHEREAS, on June 25, 2024, Resolution No. 24131 was adopted by the City Council
8 thereby adopting the two-year budget of the City of Riverside (“City”) for the fiscal years beginning
9 July 1, 2024, and ending June 30, 2025, and beginning July 1, 2025, and ending June 30, 2026; and

10 WHEREAS, the City desires to amend the two-year budget for Fiscal Year beginning July
11 1, 2025, and ending June 30, 2026; and

12 WHEREAS, the proposed amended two-year budget of the City for the Fiscal Year
13 beginning July 1, 2025, and ending June 30, 2026, consisting of one volume entitled “Proposed
14 Amended Budget for Fiscal Year 2025-2026”, has been prepared and submitted to the City Council
15 for review, consideration, and adoption, and is attached hereto and incorporated herein as Exhibit
16 “A”; and

17 WHEREAS, the City Council has caused a public hearing to be held on said budget on
18 June 17, 2025, with public notice of the hearing at least 20 days prior to said hearing, has further
19 considered the proposed budget, and has made revisions therein; and

20 WHEREAS, the City Council has given careful consideration to the adoption of an
21 amended budget and financial plan for the use of funds for Fiscal Year 2025-2026, as set forth in the
22 entitled “Proposed Amended Budget for Fiscal Year 2025-2026” and including any modifications,
23 revisions, and/or corrections made and approved by the City Council, which are incorporated by
24 reference as though fully set forth herein, and together constitute the “Adopted Budget for Fiscal
25 Year 2025-2026”; and

26 WHEREAS, Section 1103 of the Charter of the City of Riverside requires that the annual
27 budget of the City of Riverside be adopted on or before June 30th.

28 NOW THEREFORE, BE IT RESOLVED that the City Council hereby finds and
determines as follows:

1 Section 1: That the preceding recitals are true and correct and are incorporated by
2 reference as though fully set forth herein.

3 Section 2: Resolution No. 24131 is hereby amended to amend the biennial budget of
4 the City of Riverside for Fiscal Year beginning July 1, 2025, and ending June 30, 2026, prepared and
5 submitted to the City Council by the City Manager and on file in the office of the City Clerk, as
6 modified and amended by the City Council, is hereby adopted as the amended budget for Fiscal Year
7 beginning July 1, 2025, and ending June 30, 2026, on the basis of the totals set forth in each of the
8 budgets contained therein by program and/or sub-program within each department, the totals set
9 forth therein for debt redemption and interest requirements, and the totals set forth therein for capital
10 improvements.

11 Section 3: That the Chief Financial Officer/City Treasurer is authorized to expend in
12 accordance with the laws of the State of California and the laws and Charter of City of Riverside on
13 behalf of the City Council new appropriations for departments, programs, and projects as stated in
14 the “Adopted Budget for Fiscal Year 2025-2026” attached hereto as Exhibit “A” and incorporated
15 herein by reference.

16 Section 4: That, subject to availability of funds, the Chief Financial Officer/City
17 Treasurer is authorized to make the inter-fund transfers between funds as presented in the aforesaid
18 budget document and as authorized by the City Council in monthly increments of one-twelfth each
19 or such transfers may be made in lump sum amounts if necessary to finance a particular item,
20 project, program or sub-program.

21 Section 5: That the Chief Financial Officer/City Treasurer is authorized to validate,
22 sign, and pay all legal and contractual obligations of the City, including City Departments and
23 agencies, with check warrants up to the amounts appropriated in this budget.

24 Section 6: That at the conclusion of fiscal year ending June 30, 2025, certain purchase
25 orders will exist as Outstanding Encumbrances representing contractual obligations of previously
26 budgeted funds. In addition, budgeted funds for certain items or projects in various stages of
27 acquisition or development have previously been approved or will be approved by the City Council

1 to be carried forward to fiscal year 2025-2026 as Continuing Appropriations. The Outstanding
2 Encumbrances and Continuing Appropriations shall be deemed to be rebudgeted as an addition to
3 the budget amounts previously set forth in this resolution.

4 Section 7: That the City Council hereby approves the Capital Improvement Plan for
5 Fiscal Year 2025-2026, hereby accepts the Planning Commission's determination on May 8, 2025,
6 that Fiscal Year 2025-2026 capital projects are consistent with the General Plan of the City of
7 Riverside, and hereby authorizes the Chief Financial Officer/City Treasurer to transfer funding
8 between approved capital projects.

9 Section 8: That pursuant to Section 1104 of the Charter of the City of Riverside, the
10 City Council may during the fiscal year amend or supplement the budget by motion adopted by the
11 affirmative votes of at least five members so as to authorize the transfer of unused balances
12 appropriated for one purpose to another purpose or to appropriate available funds not included in the
13 budget.

14 Section 9: That this Resolution shall become effective immediately upon its passage.
