

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
4 MASTER PARKING SCHEDULE RESOLUTION TO ESTABLISH A
PREFERENTIAL PARKING ZONE ON PAISLEY COURT.

5 WHEREAS, the Public Works Department received a petition from 77% of residents on
6 Paisley Court requesting establishment of a Preferential Parking Zone ("PPZ") due to the close
7 proximity to Sycamore Highlands Park which has resulted in overflow patron parking particularly
8 during evening and overnight hours, thereby limiting on-street parking opportunities for residents
9 and creating noise concerns during late night hours; and

10 WHEREAS, the establishment of the PPZ would restrict outside parking sources during
11 evening and overnight hours and provide residents and their guests with reasonable access to on-
12 street parking and would also serve to discourage use of Sycamore Highlands Park outside of
13 designated park hours; and

14 WHEREAS, on May 6, 2015, the Transportation Board approved staff's recommendation
15 on the establishment of the proposed "No Parking between the Hours of 6:00 p.m. to 8:00 a.m.
16 Daily, with Preferential Parking for Residents" Zone on both sides of Paisley Court from
17 Abernathy Drive to the southerly terminus.

18 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
19 California, as follows:

20 Section 1: The recitals set forth above are incorporated herein by reference.

21 Section 2: That the Master Parking Schedule is hereby amended by establishing a "No
22 Parking between the Hours of 6:00 p.m. to 8:00 a.m. Daily, with Preferential Parking for
23 Residents" Zone on both sides of Paisley Court from Abernathy Drive to the southerly terminus.

24 Section 3: That the provisions of this resolution shall be operative only when signs are
25 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
26 limitations or prohibitions herein established.

27 Section 4: The provisions of this amendment shall be operative as of the date of adoption
28 of this resolution.
