BACKGROUND

4. November 15, 2023 – City's Virtual Cannabis Portal

Opened:

- Applicants electronically submitted applications and supporting documentation
- Filing deadline December 15, 2023
- Evaluation period will run forty-five (45) days after filing deadline
- Top 14 applicants will receive provisional approval to move to Phase 2

DISCUSSION

1. **Applicants have the right to appeal denial** of an application
2. **Establish Appeals Fee** to recover time and costs
3. **Engaged Consultant (MGT)** to prepare Fee Study
4. **Approach to establish fee** based on several factors:
 - Analysis of other city's fees for similar services
 - Process, staffing, time estimates
5. **Staff Recommends Deposit Based Fee Methodology**
