A RESOLUTION OF THE CITY COUNCIL OF THE CITY RIVERSIDE, CALIFORNIA, ACCEPTING THE **STATE** OF 2024-25 CALIFORNIA, DEPARTMENT JUSTICE'S TOBACCO **PROGRAM INCREASE** GRANT AWARD TO **ENFORCEMENT** REDUCING ILLEGAL ACTIVITY AIMED AΤ SALES MARKETING **CIGARETTES TOBACCO RELATED** OF AND INCLUDING **E-CIGARETTES** PRODUCTS, TO MINORS; AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO ENTER INTO AND EXECUTE OF THE ALL NECESSARY DOCUMENTS.

WHEREAS, the Riverside Police Department has applied for and received a grant award for Three Hundred Twenty Thousand Nine Hundred Ninety-Four Dollars (\$320,994.00) to increase enforcement activity aimed at reducing illegal sales and marketing of cigarettes and tobacco related products, including e-cigarettes, to minors; and

WHEREAS, certain funds are available through the Department of Justice Tobacco Grant Program to support the City's efforts to reduce underage tobacco use, sales to minors, and educational awareness to youths and retail vendors; and

WHEREAS, the grant will be implemented by the Riverside Police Department, Special Operations Vice Division, and the funding will provide overtime for two tobacco enforcement programs including Minor Decoy and Shoulder Tap; and

WHEREAS, in addition to tobacco enforcement programs, grant funding will provide training, prevention, and educational programs.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: That the grant award in the amount of Three Hundred Twenty Thousand Nine Hundred Ninety-Four Dollars (\$320,994.00) from the Department of Justice Tobacco Grant Program is hereby accepted and the City Manager of the City of Riverside, or his designee, is hereby authorized to enter into and execute the necessary documents in connection therewith, including the grant award contracts or any extensions or amendments thereof.
