- 5 PLANNING CASE PC-2026-00128 (HD): Proposal by Belen Bobadilla on behalf of the Riverside County Office of Education to consider a request to dedesignated the Structures of Merit located at 4472 & 4480 Orange and modify the Prospect Place Historic District boundary and remove the properties, situated on the east side of Orange Street, between Fourteenth Street and Prospect Avenue, in Ward 1.
