SUBJECT: AWARD BID NO. 8204 FOR THE INSTALLATION OF AN ABOVEGROUND FUEL

STORAGE TANK AT POLICE AVIATION AT THE RIVERSIDE MUNICIPAL AIRPORT TO RE CHAFFEE CONSTRUCTION, INC., OF WRIGHTWOOD, CALIFORNIA, IN THE TOTAL AMOUNT OF \$717,999, PLUS 20% CONSTRUCTION CONTINGENCY IN THE AMOUNT OF \$143.600. FOR A

**TOTAL PROJECT AMOUNT OF \$861,599** 

#### **ISSUE:**

Award Bid No. 8204 for Installation of an Aboveground Fuel Storage Tank at Police Aviation, located at 7020 Central Avenue at the Riverside Municipal Airport, to RE Chaffee Construction, Inc., of Wrightwood, California in the total amount of \$717,999, plus 20% construction contingency in the amount of \$143,600, for a total project amount of \$861,599.

#### **RECOMMENDATIONS:**

That the City Council:

- Award Bid No. 8204 for Installation of an Aboveground Fuel Storage Tank at Police Aviation, located at 7020 Central Avenue at the Riverside Municipal Airport, to RE Chaffee Construction, Inc., of Wrightwood, California, in the total amount of \$717,999;
- 2. Authorize 20% construction contingency in the amount of \$143,600 for unforeseen conditions; and
- 3. Authorize the City Manager, or designee, to execute a construction contract with RE Chaffee Construction, Inc., including making minor and non-substantive changes.

## **BACKGROUND:**

Police Aviation is located at 7020 Central Avenue at the Riverside Municipal Airport. Currently there is an underground fuel storage tank located on the property used to store fuel for Police Department aircraft. The existing underground tank is difficult to fill and there have been several spills associated with filling the tank. The monitoring and fuel delivery systems are out of date and require replacement. The installation of an aboveground fuel storage tank will address all current

fueling issues as well as reduce environmental liability. The installation will be in compliance with all federal, state, and local regulations.

## **DISCUSSION:**

On August 6, 2025, Bid No. 8204 for the Installation of an Aboveground Fuel Storage Tank at Police Aviation was published on the City's online bidding platform, PlanetBids. The proposed project includes all labor, materials, and equipment necessary to install a fully operational aboveground fuel storage tank including all site improvements, electrical connections, fuel monitoring, and fuel delivery equipment. Project construction is expected to begin upon bid award and execution of the contract documents. The existing fuel storage tank will be emptied and taken out of service as part of this project, and removed and disposed of in a future project.

The notification for Bid 8204 is summarized in the following table:

A non-mandatory pre-bid meeting was held on August 13, 2025, with six vendors in attendance. The bidding period officially closed on September 23, 2025, and a total of seven bids were received for the construction of the Project. Two bids were found to be nonresponsive due to not meeting minimum bid requirements, and five bids were found to be responsive. The lowest responsive bid was from RE Chaffee Construction, Inc., in the amount of \$717,999.
