WHEREAS. the City and Consultant entered into that certain Second Amendment to Professional Consultant Services Agreement dated July 18, 2022 ("Second Amendment"); and

WHEREAS, the City and Consultant entered into that certain Third Amendment to Professional Consultant Services Agreement dated June 12, 2023 ("Third Amendment"); and

WHEREAS, the City has been satisfied with Consultant's performance under the Agreement and desires to have Consultant continue providing the services referenced in that Agreement; and

WHEREAS, the Agreement is currently set to expire on June 30, 2024; and

WHEREAS, the City and Consultant desire to amend the Agreement to increase Compensation in the amount of Fifty Thousand Dollars (\$50,000.00), for the remaining term of the Agreement.

NOW, THEREFORE, incorporating the recitals, which are incorporated herein by this reference, City and Consultant agree as follows:

- 1. Section 3, Compensation/Payment, is hereby amended to add additional Compensation in the amount of Fifty Thousand Dollars (\$50,000.00), for the remaining term of the Agreement.
- 2. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Fourth Amendment, shall remain in full force and effect as if fully set forth herein.
