PUBLIC HEARINGS

PLANNING CASE PR-2021-001217 - CONDITIONAL USE PERMIT AND DESIGN REVIEW - 4500 ALLSTATE DRIVE, WARD 1

Proposal by Rick Jaeger of TR Design Group to consider the following entitlements: 1) Conditional Use Permit to permit the construction of a vehicle fuel station with a 7,000square-foot multi-tenant commercial building with a convenience store, a fueling canopy with 12 pumps, and off-sale of alcohol (Type 20 – Off-Sale Beer & Wine); and 2) Design Review of project plans. Regine Kennedy, Senior Planner, presented the staff Thomas Riggle, stated they were in agreement with the recommended conditions of approval. He requested that the applicant be changed to reflect Tiger Petroleum. Public Comment: Grant property owner near project. He inquired if there would be any environmental impacts on residential properties in case if a gasoline tank leaks. Ms. Kennedy responded that the project was reviewed under CEQA, those studies revealed that there would be no significant impacts. Regarding the potential gasoline tank leaks, this gas station has to abide by the Southcoast Air Quality Management District rules which mitigates for that. The public hearing was closed. Following discussion it was moved by Commissioner Mooney and seconded by Commissioner Rush to: 1) Determine that the project is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15332 (In-Fill Development Projects) of the CEQA Guidelines, as the project will not have a significant effect on the environment; and 2) Approve Planning Case PR-2021-001217 (Conditional Use Permit and Design Review), based on the findings outlined in the staff report and subject to the recommended conditions.

PLANNING CASE PR-2023-001479 – CITY ZONING AND GENERAL PLAN CONFORMITY – Southwest corner of Blaine Street and Canyon Crest Drive, Ward 1

A request by the Riverside Unified School District (RUSD) for a City Planning Commission determination of General Plan conformity and reporting on the proposed development of two parcels for a future Science, Technology, Engineering, and Mathematics (STEM) Education Center facility to support students in grades 9 through 12. Daniel Palafox, Assistant Planner, presented the staff report. Sergio San Martin, Assistant Superintendent - Operations, stated that they agreed with staff's recommendation. He provided a brief background of the project. Public Comment: Sala Ponnech, Secretary of League of United Latin American Citizens or Riverside, present to comment on behalf of LULAC; Patricia Verweel; Rich Davis, The speakers spoke in opposition and referenced issues of proximity to North High School, Impacts from UCR's planned new dorms in the area; heavy traffic, elimination of recreation facilities (baseball, softball and soccer), no parking accommodation for personnel and no drop off areas for proposed Stem facility. They also wanted the Commission know that they have spoken with RUSD Melody Clark and Joshua Zonker spoke in support. regarding these concerns. Following discussion, the Commission expressed their concerns that they are unable to see the whole project and consider all the facts. They encouraged the School District to conduct more community outreach. A motion was made by Commissioner Rush and Seconded by Commissioner Parker to: Determine the proposed development of a new STEM Education Center facility is consistent with the General Plan 2025, based on the analysis in the staff report.
