2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, ACCEPTING THE STATE OF
4 CALIFORNIA, DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL
5 ABC-OTS LOCAL ENFORCEMENT GRANT AWARD TO INCREASE
6 ENFORCEMENT ACTIVITY IN RELATION TO ALCOHOLIC
7 BEVERAGE CONTROL (ABC) VIOLATIONS; AND AUTHORIZING
8 THE EXECUTION OF THE NECESSARY DOCUMENTS BY THE CITY
9 MANAGER, OR HIS DESIGNEE.

10 WHEREAS, the Riverside Police Department has applied for and received a grant award for
11 Forty Thousand Dollars (\$40,000.00) to increase enforcement activity in relation to Alcoholic
12 Beverage Control (ABC) violations; and

13 WHEREAS, certain funds are available through the Department of Alcoholic Beverage
14 Control to increase enforcement activity and to expand the Police Department's expertise in
15 managing ABC-related problems; and

16 WHEREAS, the grant will also help incorporate ABC-related issues into Community
17 Policing by educating and involving the community in resolving alcohol-related crimes and issues
18 through education and information; and

19 WHEREAS, City of Riverside agrees to assume responsibility for any liability arising out of
20 the performance of this grant award and contract, including civil court actions for damages. The
21 State of California and ABC disclaim responsibility for any such liability.

22 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
23 California, as follows:

24 Section 1: That the grant award in the amount of Forty Thousand Dollars (\$40,000.00) from
25 the State of California, Department of Alcoholic Beverage Control, is hereby accepted and the City
26 Manager of the City of Riverside, or his designee, is hereby authorized and directed to execute the
27 necessary documents in connection therewith, including the grant award contracts or any extensions
28 or amendments thereof.

Section 2: That any liability arising out of the performance of this grant award and contract,
including civil court actions for damages, shall be the responsibility of the City of Riverside. The
State of California and ABC disclaim responsibility for any such liability.

Section 3: That any and all grant funds received hereunder shall not be used to supplant expenditures controlled by the City of Riverside.

Section 4: That this grant award is not subject to local hiring freezes.
