UPDATES ON CONFERENCES, SEMINARS AND REGIONAL MEETINGS ATTENDED BY COMMISSIONERS

Vice Chair Roberts attended the City Council meetings in May and June regarding the City of Riverside Parks, Recreation and Community Services Department's fees increases to voice the commission's reluctance of fee increases for seniors.

Chair DuBois announced she's also been listening to the Inland Empire Master Plan for Aging meetings regarding housing and behavioral health and recommends others to listen to the recorded meetings on InlandAging.com/media. She also met with City Councilmember Philip Falcone to provide feedback from the Commission on Aging. She also attended the 40th anniversary of the Janet Goeske Senior Center.

Chair DuBois and Vice Chair Roberts further discussed what was said at the City Council meeting on June 11, 2024, regarding housing in Ward 1, and the City Council meeting on April 23, 2024, regarding the leftover ARPA monies.

Chair DuBois further discussed about Inland Empire Master Plan for Aging having a one-year update on September 27, 2024, 9am-2pm in Rancho Cucamonga at their headquarters.

7. ITEMS FOR FUTURE CONSIDERATION

Vice Chair Roberts requested for future consideration of a budget, or supplies used for outreach events. Commissioner Bash would also like for supplies to be ordered for the outreach events including a canopy.

Chair DuBois would like to meet with City Staff Marnie Smith and Vice Chair Roberts to create the agenda to have more time to review and make edits. City Staff Marnie Smith clarified that the agenda has already been completed and the minutes are discussed during the commission meetings where they have a chance to request corrections. Chair DuBois would like to be more involved with the agenda creation to provide feedback regarding the speakers at the meetings. Marnie Smith explained that she keeps a list of speaker requests and invites the speakers by order received; she will be sending the list to the commission members, so they may express their opinions on the list of speakers. They can ask for it to be discussion item at a later date.

Chair DuBois would like to revisit that May is Older Americans Month and request that commissioners brainstorm events for the future. City Staff Marnie Smith announced that August is Senior Citizen Month; there will be various events for senior citizens throughout the month including the Senior Health Expo on August 21, 2024, hosted by the Department.
