ALAMO STREET AT RIVERA STREET/APPLE GROVE - TEMPORARY CUL-DE-SAC PILOT PROJECT The proposed temporary pilot project improvements anticipate the reduction or elimination of illegal dumping and illegal parking activity within the cul-de-sac and deter graffiti, loitering activity, trash, and debris accumulation. No one spoke regarding the matter.

## **COMMUNICATIONS**

## CITY COUNCIL ACTIONS ON TRAFFIC ENGINEERING-RELATED ITEMS

- a. A contract was awarded in December for installing a new traffic signal at Walkins and Big Springs.
- b. The Civil Rights Walk project was awarded.
- c. The South Main Complete Streets Project went to the City Council in February and was approved. The project involves conducting a road diet to convert the existing four-lane road on Main Street north of Third from four lanes down to two lanes.

## TRAFFIC ENGINEER UPDATES

- a. The Transportation Board WORK PLAN was forwarded to the Mobility Infrastructure Committee meeting on January 11 and was approved.
- b. The city hired a new associate traffic engineer, Jose Castellanos who specializes in traffic signal operations.
- c. MAIT report will be forwarded to June as the new lieutenant was unavailable for this meeting.

## ITEMS FOR FUTURE PLANNING COMMISSION CONSIDERATION

Chair Bulinski requested an update on the new parking access revenue control system.
