

**SECOND AMENDMENT  
TO BIOSOLIDS HAULING AND DISPOSAL/REUSE SERVICES AGREEMENT**

THIS SECOND AMENDMENT TO BIOSOLIDS HAULING AND DISPOSAL/REUSE SERVICES AGREEMENT (“Second Amendment”) is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2022, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and DENALI WATER SOLUTIONS, LLC, a Delaware limited liability company authorized to do business in California (“Contractor”), with respect to the following:

**RECITALS**

WHEREAS, on April 22, 2016, City and Contractor entered into that certain Biosolids Hauling and Disposal/Reuse Services Agreement for Biosolids hauling and disposal Services for Riverside Regional Water Quality Control Plant; and

WHEREAS, on September 27, 2018, City and Contractor entered into that certain First Amendment to Biosolids Hauling and Disposal/Reuse Services Agreement (“First Amendment”), to extend the term of the Agreement and increase compensation during the extended term of the Agreement; and

WHEREAS, the Agreement is set to expire on June 30, 2022; and

WHEREAS, the City and Contractor desire to extend the term of the Agreement for an additional six (6) months, to December 31, 2022, and increase the compensation during the extended term by an additional Eight Hundred Thousand Dollars (\$800,000.00); and

WHEREAS, the increase in compensation is due to an increase in hauling and disposal service rates from Contractor.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and Consultant agree as follows:

1. Section 3, Term of the Agreement, is amended to extend the term by six (6) months, to December 31, 2022.

2. Section 4, “Compensation,” of the Agreement, is amended to add an additional Eight Hundred Thousand Dollars (\$800,000.00), for the extended term of the Agreement, for a new contract total of Sixteen Million One Hundred Eighty-Six Thousand Two Hundred and Eleven Dollars (\$16,186,211.00). City shall pay Contractor in accordance with the service rates set forth in Exhibit “B-2,” attached hereto and incorporated herein.


