YOU ARE HEREBY NOTIFIED that the City Council of the City of Riverside will hold a virtual and in-person Public Hearing regarding the following item:

CASE NUMBER: PR-2022-001453 (AMD)

APPLICANT: City of Riverside

LOCATION: Citywide

PROPOSAL: The City Council Economic Development, Placemaking and Branding/Marketing Committee recommends the City Council approve a proposal to amend Title 5 (Business Taxes, Licenses and Regulations), Title 9 – (Peace, Safety and Morals), and Title 19 (Zoning) of the Riverside Municipal Code. The proposed amendments are intended to: (1) establish procedures and regulations to implement a Cannabis Business Permit Program; (2) implement provisions of the State Law as it relates to commercial cannabis use and sales; (3) revise language and terminology for consistency throughout Titles 5, 9 and 19 of the Municipal Code; (4) establish Definitions related to the proposed Cannabis Business Permit Program; and (5) make other minor technical and non-substantive changes as necessary.
