2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, ESTABLISHING THE AUTHORIZED AGENTS OF THE
4 CITY OF RIVERSIDE FOR FILING APPLICATIONS AND REQUESTING
5 RELEASE OF FUNDS FOR FEDERAL ASSISTANCE FROM THE
6 CALIFORNIA OFFICE OF EMERGENCY SERVICES (CALOES) AND/OR
7 STATE FINANCIAL ASSISTANCE UNDER THE CALIFORNIA
8 DISASTER ASSISTANCE ACT

9 WHEREAS, the City Council of the City of Riverside has the authority to file an application
10 for federal assistance and request the release of funds from the California Office of Emergency
11 Services for federal and/or state assistance or disaster relief and/or state financial assistance under the
12 California Disaster Assistance Act; and

13 WHEREAS, the City Council of the City of Riverside desires to designate its agents to provide
14 for all matters pertaining to such federal and state disaster assistance the assurances and agreements
15 require; and

16 WHEREAS, the City Council of the City of Riverside is authorizing the City Manager,
17 Assistant City Manager, the Fire Chief, or the Emergency Services Administrator to execute for and
18 on behalf of the City of Riverside, a California charter city and municipal corporation, to file an
19 application in the office of the California Office of Emergency Services (CalOES) for the purpose of
20 obtaining certain federal assistance Under P.L. 93-288 as amended by the Robert T. Stafford Disaster
21 Relief and Emergency Assistance Act of 1988, and/or state financial assistance under the California
22 Disaster Assistance Act; and

23 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
24 California, as follows:

25 Section 1: That the City Manager, Assistant City Manager, Fire Chief, and/or Emergency
26 Services Administrator of the City of Riverside are authorized to file an application for the purpose of
27 obtaining federal assistance under Public Law 93-288 as amended by the Robert T. Stafford Relief
28 and Emergency Assistance Act of 1988, and/or state financial assistance under the California Disaster
Assistance Act.
