SUBJECT: AWARD BID NO. 8211 FOR THE CONSTRUCTION OF FAIRMOUNT PARK

STORM DRAIN - DEXTER DRIVE TO BOWLING GREEN DRIVE, PHASE I TO VORTEX SERVICES, LLC, OF HOUSTON, TEXAS IN THE AMOUNT OF

\$556,200

## **ISSUE:**

Award Bid No. 8211 for the construction of Fairmount Park Storm Drain – Dexter Drive to Bowling Green Drive, Phase I to Vortex Services, LLC, of Houston, Texas, in the amount of \$556,200.

#### **RECOMMENDATIONS:**

That the City Council:

- 1. Award Bid No. 8211 for Fairmount Park Storm Drain Dexter Drive to Bowling Green Drive, Phase I to Vortex Services, LLC, of Houston, Texas, in the amount of \$556,200; and
- 2. Authorize the City Manager, or his designee, to execute the construction contract with Vortex Services, LLC., including making minor non-substantial changes.

#### **BACKGROUND:**

The storm drain pipes for Fairmount Park were Constructed in 1984 as part of the Fairmount lakes rehabilitation. The storm drain lines were cleaned and video inspected partially in 2016. The storm drain is an important component of the drainage system at Fairmount Park.

In November 2020, the City approved Eaglelift Inc.'s proposal, in the amount of \$10,000, to complete joint repairs at 10 locations for the 36" reinforced concrete storm drain pipe at Dexter Dr and Field LN (approx. 458 FL Manhole to Manhole). The objective was to fill the voids around the pipe to seal the joints and prevent infiltration or exfiltration, and to lift settled sections of the pipe.

On March 19, 2021, the City executed an agreement with Pipe Tec Inc. for cleaning and video inspection of the existing Fairmount Park 36 inch storm drain in the amount of \$30,000.

Despite efforts to clean and repair the pipes, the pipes are not performing according to the design intent due to erosion and sediment accumulation. Public Works staff identified that additional work was needed to ensure adequate flow through the pipes; however, this work is pending until a

planned downstream maintenance project was completed to remove sediment from the outfall of the pipe. This additional maintenance work, under the supervision of the Parks, Recreation and Community Services Department (PRCS), would help ensure positive drainage flow downstream of the pipes and reduce the work needed to dewater the pipes during construction. With the downstream maintenance scheduled and necessary permits secured by PRCS in mid-2024, Public Works proceeded to schedule the storm drain work. Work by PRCS is scheduled to be completed by December 2025.

## **DISCUSSION:**

On September 18, 2025, Bid No. 8211 for the Fairmount Park Storm Drain – Dexter Drive to Bowling Green Drive Phase 1 was posted on PlanetBids. The proposed project entails cleaning and lining the existing 36" reinforced concrete storm drain main line. Prior to bid opening, there was one (1) question received and answered, and no addenda were issued. The bidding notification table is summarized below in Table 1.

On October 19, 2025, three (3) bids were received for the construction of the project (Attachment 2). Siterep Construction Services, Inc., was deemed a non-responsive due to greater than 50% of bid being from a subcontractor. The lowest responsive bid was from Vortex Services, LLC, in the amount of \$556,200, which is 2.71% over the Engineer's Estimate as shown below in Table 2.

## **FISCAL IMPACT**:

The total fiscal impact of the award of the construction agreement is \$556,200. The total project costs includes 10% change order authority, design, construction and construction engineering, as outlined in Table 3. Sufficient funds are budgeted and available to award the contract and complete the project as outlined in Table 4.
