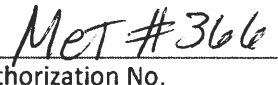

RE: Request for Member Agency Administered Program Funds

On March 8, 2019, Riverside Public Utilities' (RPU) Customer Engagement Group will release a Request For Proposals (RFP) to seek competitive bids from qualified contractors to continue program administration of the Smart Irrigation Program (SIP). SIP actively targets high outdoor water-using residential and commercial customers to improve landscape irrigation efficiency. The SIP contractor provides customers landscape irrigation evaluations and professionally installed weather-based irrigation controllers and high-efficiency irrigation nozzles for pop-up spray-heads. In addition, SIP offers customers minor improvements to their existing irrigation system to prepare the property to participate in the program, as well as water management services for customers who are interested in saving water but do not need services offered by the direct installation portion of the program.

Riverside Public Utilities would like to request \$50,000 from the Member Agency Administered Program fund to implement the Smart Irrigation Program. The funding request is for 25% of the total program budget of \$200,000. RPU plans on launching the Smart Irrigation Program on July 1, 2019, pending Board and City Council consideration and approval.
