A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
CALIFORNIA, AMENDING RESOLUTION NO. 22451 KNOWN AS THE
MASTER PARKING SCHEDULE RESOLUTION TO REMOVE A SEGMENT
OF TIMED NO PARKING ZONE ON IRVING STREET.

WHEREAS, the Public Works Department received a petition from one hundred percent (100%) of the three residences located on the easterly side of Irving Street north of Cherbourg Drive to remove the portion of the existing Timed No Parking Zone adjacent to their properties; and

WHEREAS, the restriction was implemented years ago to address overflow parking from nearby Arlington High School when on-site parking was limited and the school operated as an open campus which allowed students to leave the premises for lunch; and

WHEREAS, Arlington High School is now a closed campus which requires students to remain on campus through the entire school day, and the westerly school parking lot has been expanded to provide sufficient on-site parking for students, faculty, and visitors; and

WHEREAS, removal of the proposed segment of Timed No Parking Zone would increase on-street parking opportunities for residents and their guests and meet the current parking needs of the impacted residents, and

WHEREAS, on May 6, 2015, the Transportation Board approved staff's recommendation to remove the segment of "No Parking between the Hours of 8:00 a.m. to 4:00 p.m. Monday through Friday, except Holidays" Zone on the easterly side of Irving Street from Cherbourg Drive to the northerly terminus.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: The recitals set forth above are incorporated herein by reference.

Section 2: That the Master Parking Schedule is hereby amended by removing the segment of "No Parking between the Hours of 8:00 a.m. to 4:00 p.m. Monday through Friday, except Holidays" Zone on the easterly side of Irving Street from Cherbourg Drive to the northerly terminus.

1 Section 3: That the provisions of this resolution shall be operative only when signs are
2 erected on that portion of the street set forth in Section 2 above, giving notice of the parking
3 limitations or prohibitions herein established.

4 Section 4: The provisions of this amendment shall be operative as of the date of adoption
5 of this resolution.
