

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE ON
4 BEHALF OF THE CITY OF RIVERSIDE ALL NECESSARY APPLICATIONS,
5 CONTRACTS, PAYMENT REQUESTS, AGREEMENTS AND
6 AMENDMENTS IN THE PROCESS OF APPLYING FOR AND SECURING
7 FUNDS UNDER THE CALIFORNIA DEPARTMENT OF WATER
8 RESOURCES URBAN COMMUNITY DROUGHT RELIEF GRANT
9 PROGRAM

10 WHEREAS, the California Department of Water Resources (“Department”) administers the
11 Urban Community Drought Relief Grant Program (“Program”); and

12 WHEREAS, in furtherance of this authority, the Department is required to establish procedures
13 governing the application, awarding and management of the Program grants; and

14 WHEREAS, the Department’s Program application procedures require an applicant’s
15 governing body to declare by resolution certain authorizations related to the administration of Program
16 grants; and

17 WHEREAS, the City of Riverside (“City”) desires to apply for funds from the Program and
18 also desires to extend the City Manager’s authority to include the authority to apply for and secure the
19 available funds on behalf of the City available under the Department’s Program, and carryout all other
20 purposes in the application process administered by the Department.

21 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
22 California, as follows:

23 Section 1: The City Council of the City of Riverside does hereby authorize application to
24 California Department of Water Resources for a grant from the Urban Community Drought Relief
25 Grant Program (“Program”).

26 Section 2: The City Manager, or designee, (“Authorized Representative”) is hereby authorized
27 and empowered to execute on behalf of the City all necessary documents, including but not limited to
28 a funding agreement, applications, payment requests, invoices, progress reports, agreements and
amendments thereto, necessary to secure grant funds and to implement the approved grant project.

Section 3: The Authorized Representative, is designated to provide the assurances,
certifications, and commitments required for the grant funding application, including executing a
funding agreement from the California Department of Water Resources and any amendments or

changes thereto.

Section 4: The Authorized Representative is designated to represent the City in carrying out the City's responsibilities under the grant agreement, including certifying disbursements required on behalf of the City and compliance with applicable state and federal laws.
