## **LEGISLATIVE HISTORY**

Assembly Bill (AB) 1890 was adopted in 1996, which required publicly owned utilities to collect and spend Public Benefits Charge funds for low-income assistance, energy efficiency and conservation programs, renewable energy, and research, development, and demonstration projects.

## **BACKGROUND**

- Sharing Households Assist Riverside's Energy SHARE Program established in 1989 initially supported by direct customer contributions
- 2. May 22, 2018: City Council approved first enhancement:
  - a. Expanded to 200% Federal Poverty Level
  - b. Established monthly assistance amounts
  - c. Agreement with Community Action Partnership (CAP) established five (5) one-year automatic renewal periods
  - d. Funding: \$2.8 million per year

## **BACKGROUND**

3. Community Action Partnership (CAP) processes a proportion of all SHARE applications.

| Year  | Applications Processed |
|-------|------------------------|
| 18/19 | 4,598                  |
| 19/20 | 2,890                  |
| 20/21 | 1,474                  |
| 21/22 | 1,344                  |
| 22/23 | 1,914                  |
| Total | 12,220                 |

4. Program has assisted over 110,000 low-income residential customers since 1989

## **BACKGROUND**

- 5. Current Agreement with CAP expires 6/30/2024
- 6. New contract to mirror terms of previous, will renew in five 1year terms
- 7. Annual funding amount remains unchanged:
  - a. \$2,550,000 for customer assistance
  - b. \$250,000 for the County's administration fee
  - c. \$27 per application

## **DISCUSSION**

- SHARE assistance is \$250 for deposit/urgent notice provision and \$20 a month electric assistance for qualified, low-income customers
- 2. SHARE provides monthly water and solid waste assistance
- 3. Income qualification is set at 250% (City Council: May 17, 2022) of Federal Poverty Level, income level is revised annually
- 4. Collaboration enables low-income customers to access RPU assistance programs while at the same time CAP can help the same customers with State, County and Federal assistance programs in one location.
- 5. Collaboration with CAP provides RPU flexibility to manager other energy efficiency and water conservation rebates and programs

## **RECOMMENDATIONS**

That the Board of Public Utilities recommend that the City Council:

- Approve the First Amended and Restated Agreement for Use of Low-Income Utility Bill and Deposit Assistance Funds with the County of Riverside, on behalf of Community Action Partnership of Riverside County for SHARE to include options to extend the program from July 1, 2024, through June 30, 2029, for an annual program amount of \$2,800,000; and
- 2. Authorize the City Manager, or their designee, to execute the First Amendment to the Amended and Restated Agreement for Use of Low-Income Utility Bill Deposit Assistance Funds with the State of California, on behalf of Community Action Partnership of Riverside County, including making non-substantive changes.
