SUBJECT: RIVERSIDE COUNTY PROBATION DEPARTMENT AND POST-RELEASE ACCOUNTABILITY AND COMPLIANCE TEAM FOR PUBLIC SAFETY REALIGNMENT MEMORANDUM OF UNDERSTANDING FOR REIMBURSEMENT OF PERSONNEL COSTS AND HOST AGENCY ALLOCATION IN THE TOTAL AMOUNT OF \$480,000 – SUPPLEMENTAL APPROPRIATION

ISSUES:

Approve the Riverside County Probation Department and Post-Release Accountability and Compliance Team for Public Safety Realignment Memorandum of Understanding; accept \$215,000 from the Riverside County Probation Department and \$265,000 from the State, through the City of Corona, for Post-Release Accountability and Compliance Team reimbursement; and authorize a supplemental appropriation in the amount of \$480,000 for personnel costs related to the Post-Release Accountability and Compliance Team.

RECOMMENDATIONS:

That the City Council:

1. Approve the Riverside County Probation Department and Post-Release Accountability and Compliance Team for Public Safety Realignment Memorandum of Understanding;
2. Accept Riverside County Probation Department funds in the amount of \$215,000 for reimbursement of City personnel costs related to Post-Release Accountability and Compliance Team;
3. Accept State funds, through the City of Corona, in the amount of \$265,000 for personnel costs related to the Post-Release Accountability and Compliance Team;
4. Authorize a supplemental appropriation of revenue in the amount of \$480,000 to be offset by expenditures in the same amount to an account as established by the Finance Department for personnel costs related to the Post-Release Accountability and Compliance Team; and

5. Authorize the City Manager, or his designee, to execute all the necessary documents including making minor non-substantive changes to those documents.

LEGISLATIVE HISTORY:

On October 1, 2011, the State of California implemented Assembly Bill (AB) 109, realigning the State corrections system and placing the responsibility of supervising criminals that were previously supervised by the State Department of Corrections under the supervision of local county probation departments. Realignment also shifted the housing of criminals who would have previously been placed into State correctional facilities under the jurisdiction and responsibility of the county sheriff's department.

BACKGROUND:

The Riverside County Community Corrections Partnership Executive Committee recognized the need for local law enforcement participation in the oversight of these new AB 109 probationers, and allocated funding to form an AB 109 Post-Release Accountability and Compliance Team (PACT) to partner with the County's Probation Department to deal with the impacts on local communities.

On January 6, 2015, the City Council approved to enter into a Memorandum of Understanding (MOU) with the Riverside County Probation Department for the Post-Release Accountability and Compliance Team.

DISCUSSION:

In December of 2016, the Riverside County Probation Department prepared a new MOU and advised the City that \$215,000 has been made available for costs associated with PACT for FY2016/17. In addition to these funds, the State, through the City of Corona, has provided an additional \$265,000 for personnel costs related to PACT.

The Department will use the funds to reimburse personnel costs related to PACT.

FISCAL IMPACT:

The total funding received is \$480,000; funds will be used to reimburse the General Fund for personnel costs related to the PACT. No matching funds are required.
