Drive, in Ward 4


**PROPOSAL:** A referral, on behalf of Councilmember Cervantes, of an approval by the Community & Economic Development Department Director for a proposal by Jerardo Reyes and Ryan Williams to consider the following entitlements: 1) Tentative Parcel Map (No. 38174) to subdivide a 5.74-acre parcel into four parcels for residential purposes; and 2) Grading Exception to allow grading within the Prenda Arroyo and the 50-foot arroyo setback.

**ENVIRONMENTAL DETERMINATION:** The Planning Division of the Community & Economic Development Department recommends the City Council determine that the proposed project will not have a significant effect on the environment based on the findings set forth in the case record and adopt a Mitigated Negative Declaration (MND) and Mitigation Monitoring and Reporting Program (MMRP), pursuant to Sections 15074 and 21081.6 of the California Environmental Quality Act (CEQA) Guidelines.
