LEGAL DESCRIPTION

That certain real property located in the City of Riverside, County of Riverside, State of California, described as follows:

All that portion of Lot 7 in Block 10 of La Granada, as shown by map on file in Book 12, Pages 42 to 51 of Maps, Records of Riverside County, California, described as follows:

BEGINNING at the most northerly corner of said Lot 7;

Thence South $30^{\circ}19'$ East, along the northeasterly line of said Lot 7, a distance of 173.00 feet to the most easterly corner thereof;

Thence South $45^{\circ}54'34''$ West, along the southeasterly line of said Lot 7, a distance of 75.00 feet;

Thence North $30^{\circ}05'52''$ West, a distance of 170.53 feet to a point on the northwesterly line of said Lot 7, distant thereon 75.00 feet southwesterly of the most northerly corner thereof;

Thence North $43^{\circ}57'13''$ East, along said northwesterly line, a distance of 75.00 feet to the **POINT OF BEGINNING**;

EXCEPTING THEREFROM that portion lying northeasterly, northerly and northwesterly of the following described line:

COMMENCING at the most northerly corner of said Lot 7;

Thence South $30^{\circ}19'$ East, along the northeasterly line of said Lot 7, a distance of 173.00 feet to the most easterly corner thereof;

Thence South $45^{\circ}54'34''$ West, along the southeasterly line of said Lot 7, a distance of 30.89 Feet to a line parallel with and distant 55.00 feet southwesterly, measured at right angles from the centerline of Tyler Street (formerly Tyler Avenue) as shown on said La Granada and to the **POINT OF BEGINNING**;

Thence North $30^{\circ}19'00''$ West, along said parallel line, a distance of 132.18 feet;

Thence North $82^{\circ}15'30''$ West, a distance of 37.47 feet to a line parallel with and distant 33.00 feet southeasterly, measured at right angles from the centerline of Wells Avenue as shown on said La Granada;


Thence South 43°57'13" West, along said parallel line, a distance of 13.21 feet to a point in the southwest line of the above described parcel and the **END** of this Line Description.
