

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO.  
4 21052 AND THE MASTER FRINGE BENEFITS AND SALARY  
5 PLAN TO APPROVE AN ADDITIONAL STEP FOR THE  
6 SENIOR MECHANIC CLASSIFICATION; DELETION OF NON-  
UTILIZED CLASSIFICATIONS; AND APPROVE ADDITIONAL  
FIVE PERCENT SPECIAL COMPENSATION FOR CNG FUEL  
ISLAND ASSIGNMENT.

7 WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council  
8 thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and

9 WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees;  
10 and

11 WHEREAS, the FBSP has been amended several times to update the benefits and  
12 salaries; and

13 WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect an additional  
14 step for the Senior Mechanic classification and deletion of the Senior Mechanic Specialist  
15 classification.

16 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as  
17 follows:

18 Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are  
19 hereby amended to: 1) approve an additional step for the Senior Mechanic classification and  
20 deletion of the Senior Mechanic Specialist classification; and 2) approve an additional five  
21 percent (5%) special compensation for employees in the Fire Mechanic, Mechanic, and Senior  
22 Mechanic classifications when assigned to the CNG fuel island, all as set forth in Exhibit "A"  
23 and Exhibit "B" attached hereto and incorporated herein by reference.

24 Section 2: Authorize the City Manager, or designee, to make minor, non-substantive  
25 changes to the Master Fringe Benefits and Salary Plan and any related policies, procedures or  
26 documents necessary to implement these provisions.

27 Section 3: The provisions of this resolution shall be operative upon adoption.
