
Mayor Lock Dawson called the meeting to order at 3:00 p.m.


#### PUBLIC HEARING



**CHANGE ORDER TO BID 8179 - RENOVATIONS - CITY ATTORNEY'S OFFICE - 3750 UNIVERSITY**  
The City Council (1) approved a change order in the total amount of \$111,211.34 to Bid 8179 to add Phases 1-3 for flooring replacement including moving furniture and a carpeting substitution, plus 10 percent contingency in the amount of \$11,121 for a revised total project of \$172,296.65; and (2) authorized the City Manager, or designee, to execute Change Order 001 and all related documents.

#### BOARDS AND COMMISSIONS RESIGNATIONS

The Mayor and City Council filed the resignations of (1) Nora Moti from the Commission on Aging Ward 2 seat; and (2) Steven Herrera from the Cultural Heritage Board Ward 2 seat, effective immediately.



#### CITY COUNCIL MEETING CANCELLATION

The City Council cancelled the regularly scheduled City Council meeting of Tuesday, December 16, 2025, for lack of agenda items.

#### PLANNING CASE PR-2023-001595 SUMMARY STREET/ALLEY VACATION - RESOLUTION

The City Council (1) determined that this proposal is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) (Common Sense) of the CEQA Guidelines, as it can be seen with certainty that there is no possibility the project will have a significant effect on the environment; (2) approved Planning Case PR-2023-001595 (VC-S) for the Summary Street/Alley Vacation of 10,254 square feet of existing unimproved alleys and a portion of 11th Street, subject to the recommended conditions of approval; (3) adopted a Resolution vacating the exiting unimproved alley pursuant to the Public Streets, Highways and Service Easements Vacation Law; and

(4) authorized the City Manager, or his designee, to execute quitclaim deeds associated with the summary street vacation as necessary.


Whereupon, the title having been read and further reading waived, Resolution No. 24332 of the City Council of the City of Riverside, California, Providing for the Summary Vacation (Case No. PR-2023-001595) of an Approximately 10,254-Square-Foot Excess Right-of-Way Street, Located on the West Side of Howard Avenue, Between 10th and 12th Streets, was presented and adopted.

**JOINT COMMUNITY FACILITES AGREEMENT - RESOLUTION - SUPPLEMENTAL APPROPRIATION**  
The City Council (1) approved a Joint Community Facilities Agreement between the City of Riverside, Riverside Unified School District, and Century Communities of California, LLC.; (2) adopted a Resolution approving the execution of the Joint Community Facilities Agreement by the City Manager, or designee, which will allow formation of the Community Facilities District No. 42 of the Riverside Unified School District; (3) authorized the City Manager, or designee, to execute the Joint Community Facilities Agreement, related documents and the ability to make minor non-substantive changes; and (4) authorized the Chief Financial Officer, or designee, to record supplemental appropriation and all other accounting and financial transactions, to record bond proceeds to eligible tax-exempt capital projects.

Whereupon, the title having been read and further reading waived, Resolution No. 24333 of the City Council of the City of Riverside, Approving a Joint Community Facilities Agreement with Riverside Unified School District and Century Communities of California, LLC., for Community Facilities District No. 42 of Riverside Unified School District, was presented and adopted.

**COMMUNITY FACILITIES DISTRICT NO. 2025-2 SAGECREST - ORDINANCE ADOPTED**  
The City Council adopted an Ordinance authorizing the levy of special taxes within Community Facilities District 2025-2 Sagecrest.

Whereupon, the title having been read and further reading waive, Ordinance No. 7750 of the City Council of the City of Riverside, Acting in its Capacity as the Legislative Body of Community Facilities District No. 2025-2 (Sagecrest) of the City of Riverside Authorizing the Levy of Special Taxes, was presented and adopted.

#### CALIFORNIA FIRE FIGHTER JOINT APPRENTICESHIP COMMITTEE FIRE TRAINING SUPPORT REIMBURSEMENT - SUPPLEMENTAL APPROPRIATION

The City Council (1) authorized acceptance of training reimbursement funds from California Fire Fighter Joint Apprenticeship Committee in the amount of \$100,000; and (2) authorized the Chief Financial Officer, or his designee, to record an increase in revenue and appropriate expenditures in the equal amount of \$100,000 in the Grants and Restricted Programs Fund, California Fire Fighter Joint Apprenticeship Committee revenue and expenditure accounts.

#### AGREEMENT - DEFINED CONTRIBUTION PLAN CONSULTANT AND INVESTMENT ADVISOR

The City Council (1) approved the Professional Services Agreement with Shuster Advisory Group, LLC., in accordance with Purchasing Resolution 24101, Section 702 (f) through December 31, 2028, with an option to extend for two additional one-year terms; and (2) authorized the City Manager, or designee, to execute the Professional Services Agreement with Shuster Advisory Group, LLC., and all related documents, including making any minor non-substantive changes as necessary to effectuate the Agreement.


#### RIVERSIDE MUNICIPAL CODE AMENDMENT - SECTION 2.09 - ORDINANCE ADOPTED

The City Council adopted an Ordinance amending Sections 2.08.010 and 2.08.020 and adding Section 2.09 to the Riverside Municipal Code regarding the Office of the Inspector General as an administrative office and department of the City and retention of outside counsel by the Inspector General, if needed, was presented and adopted. Councilmember Falcone voted no.

Whereupon, the title having been read and further reading waive, Ordinance No. 7751 of the City of Riverside, California, Amending Sections 2.08.010 and 2.08.020 and Adding Section 2.09 of the Riverside Municipal Code Regarding the Office of the Inspector General as an Administrative Office and Department of the City and Retention of Outside Council by the Inspector General, was presented and adopted.

#### INCREASE PURCHASE ORDER 260025 - LIBRARY MATERIALS AND SERVICES

The City Council (1) approved an increase in Purchase Order 260025 with Brodart Co., McElhattan, Pennsylvania, in the amount of \$116,829 for a revised purchase order amount of \$206,829 for the purchase of library materials and services; and (2) authorized the City Manager, or designee, to execute all documents necessary to complete the purchase including making minor and non-substantive changes and extensions.

#### REQUEST FOR PROPOSAL 2444 AGREEMENT - DIGITAL RADIOS AND INSTALLATIONS

The City Council (1) approved the Digital Radios and Installations Services Agreement, from Request for Proposal 2444 for the Special Transportation Division with Rivcomm, Inc., Riverside, in the amount of \$203,695.75, for a one-year term with the option to extend for one additional one-year term; (2) authorized 10 percent change order authority on the base contract price in the amount of \$20,369.57, for a total contract amount of \$224,065.32; and (3) authorized the City Manager, or designee, to execute the Agreement for Digital Radios and Installations Services for the Special Transportation Division with Rivcomm, Inc., including an extension for an additional one-year term subject to budget approval, and making minor and non-substantive changes.

#### RIVERSIDE PUBLIC UTILITIES FISCAL AND CASH RESERVE POLICY UPDATE

The City Council approved the updated Riverside Public Utilities Fiscal and Cash Reserve Policy to establish the Section 115 Pension Trust - Unfunded Accrued Liability Reserve, including the approved Water Treatment Reserve, water fund only, and to clarify certain existing policy definitions.

#### ENERGY EFFICIENCY AND DEMAND REDUCTION


The City Council approved the Riverside Public Utilities updated Energy Efficiency and Demand Reduction ten-year target of 0.36 percent of annual projected retail energy sales for the period beginning 2026 through 2035.

#### FISCAL YEAR 2024-2025 SOUTHERN CALIFORNIA PUBLIC POWER AUTHORITY SEMI-ANNUAL EXPENDITURE REPORT

The City Council received the Southern California Public Power Authority semi-annual expenditure report for Fiscal Year 2024-2025.

#### AWARD BID 8201 - STORM DRAIN IMPROVEMENT PROJECT - HOUGHTON

The City Council (1) awarded Bid 8201 for the construction of Houghton Avenue Storm Drain Improvements to GHC Pipeline, LLC., Riverside, in the amount of \$248,489; and (2) authorized the City Manager, or his designee, to execute the construction contract with GHC Pipeline, LLC., including making minor non-substantial changes.

#### VOLUNTARY PARTICIPATION IN WESTERN RIVERSIDE COUNCIL OF GOVERNMENTS VEHICLE MILES TRAVELED MITIGATION PROGRAM - CREDIT GENERATOR PARTICIPATION AGREEMENT

The City Council (1) approved the City's participation in the voluntary Western Riverside Council of Governments Vehicle Miles Traveled Mitigation Program; (2) authorized the City Manager or designee to enter into a Credit Generator Participation Agreement with the Western Riverside Council of Governments; and (3) directed staff to coordinate with Western Riverside Council of Governments to add Vehicle Miles Traveled reducing improvement projects into the voluntary program to address development projects with transportation related Vehicle Miles Traveled impacts.

#### CITY GENERAL PLAN CIRCULATION AND COMMUNITY MOBILITY ELEMENT - STREET CROSS-SECTION REDUCTION

The City Council approved a street cross-section reduction from the City General Plan Circulation and Community Mobility Element when the Public Works Department is completing street improvement projects.

#### RIVERSIDE MUNICIPAL CODE AMENDMENT - CHAPTER 3.30 - ORDINANCE ADOPTED


The City Council adopted an Ordinance revising Chapter 3.30, Section 3.30.030 XI of the Riverside Municipal Code to add an additional category under titled Valet Parking under Schedule of Regulation, Products and Services, subsection XI - Public Parking - Public Works.

Whereupon, the title having been read and further reading waive, Ordinance No. 7752 of the City of Riverside, California, Amending Chapter 3.30 of the Riverside Municipal Code, to add one Subsection to the Schedule of Regulation, Products, and Services, was presented and adopted.
