#### HOUSING BARRIERS FACED BY FORMERLY INCARCERATED PEOPLE AND THEIR FAMILIES

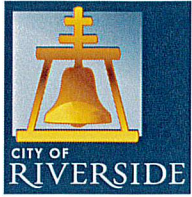

The motion carried unanimously.
