Although prior year month compared to current year month was essentially flat, aircraft operational counts for the entire year of 2024 set a new annual record, at 144,092. This represents an increase of 10.4% over 2023.

Now seven months into the current Fiscal Year, we are 58.33% through the budget year. Revenues continue to track higher than budgeted, currently at 61.0% of budget. Expenditures continue to track below budget, currently at 52.4% of budget. As the airport continues to improve, projects are carried out either in-house or through the competitive bidding process. Revenues are enhanced through near 100% occupancy of hangars and the expanded partnership with Manheim Auto Auction as they additionally leased 18 acres on the airport's westside.

# Ohmio Testing

Ohmio has opened its international headquarters, research and design, and manufacturing facility on Airport Drive. They held their grand opening on Tuesday and the all-electric, autonomous shuttles deployed last week. The City of Riverside recruited Ohmio from New Zealand and leased 3 shuttles for 2 years to deploy throughout the City. The City partnered with RTA who will operate and maintain the shuttles with the first route being Airport Drive and Gemende. The shuttle will stop in front of the airport terminal.

## Blue Zone Community Kickoff Event

Blue Zones Community Kickoff Event on Saturday, May 17. The City and several partners including Kaiser Permanente, Inland Empire Health Plan, Molina Heath Care, Riverside University Health System, have come together for the first time to undergo a 5-year program to get the City of Riverside certified as a blue zone. The kick-off event is here at the Riverside Airport. Blue Zones is a community-wide well-being improvement initiative designed to make healthy choices easier. Blue Zones is informed by the company's identification of and research about the regions of the world with the highest concentrations of centenarians (people who live to be 100 years or older). Blue Zones seeks to improve the overall well-being of your community's residents.
