The minutes of September 11, 2024, were approved without amendments.

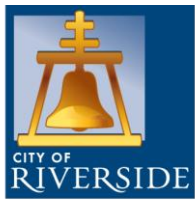
ATTENDANCE

COTD AD HOC COMMITTEE UPDATES

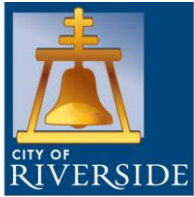
Commissioner Rasmus provided a brief report on the workplan.
