BACKGROUND

- 1. The Active Transportation Program is administered by Caltrans to enhance public health and achieve equityoriented outcomes through the deployment of biking and walking infrastructure
- 2. The City has participated in the ATP program with multiple successes since its inception in 2014
- 3. On June 7, 2022 the City Council authorized submittal of a grant application for the Civil Rights Walk



PROJECT BACKGROUND

- 1. On August 7, 2023, the Public Works Department was awarded an Active Transportation Program Cycle VI grant application to connect multiple points of historic interest in the Downtown and adjoining areas to create a Riverside Civil Rights Walk
- 2. On October 30, 2023, an initial presentation was provided during the first meeting with key stakeholders regarding the Civil Rights Walk Project.
- On December 12, 2023, the Public Works Department will request City Council to <u>accept of an additional \$876,000 in grant</u> <u>funds</u> (total project cost of \$3,216,000) for the Civil Rights Walk

DISCUSSION

- The Civil Rights Walk features a core
 1.8 mile loop with thermoplastic markings routing walkers to multiple points of interest
- 2. Project would be similar to the Boston Freedom Trail
- 3. The expanded 2.9 mile loop features additional points of interest
- 4. Would use technology such as "Guide By Cell" or similar








 Reconstruct sidewalks, driveways, curb ramps


- 5. Construct Path


