Following discussion and without formal motion, the Committee received and ordered filed the report of the City of Riverside's non-potable and recycled water resources.


#### **VISION ZERO POLICY**

Following discussion, it was moved by Member Perry and seconded by Vice Chair Hemenway to recommend that the City Council (1) adopt a Resolution establishing a Vision Zero policy to work towards a fifty percent reduction of preventable traffic deaths and severe injuries by 2040; and (2) directed staff to develop a City of Riverside Vision Zero Action Plan (VZAP) in alignment with existing national, state, and regional programs and grant funding requirements. The motion carried unanimously.

routes and site regulations, staff concerns, and timeline; and (2) Senate Bill 569 regarding Homeless Encampment Collaboration Act as staff has been collaborating with Caltrans to discuss methods to improve the process for clearing encampments in their rights-of-way such as under ramps and underpasses.

#### PROJECT UPDATES

Public Works Deputy Director Nathan Mustafa (1) introduced City Surveyor Doug Webber who provided an update on survey technology and on the Survey and Land Development Division; (2) provided information regarding three grants related to the Highway Safety Improvement Program including (a) upgrades to the remaining traffic signal controllers throughout the City; (b) installation of pedestrian fencing at problematic medians and crosswalks; and (c) installation of a buffer bike lane between Arlington and Magnolia Avenues along Van Buren Boulevard totaling approximately \$6.5 million in funding for the projects; (3) announced the receipt of a study grant from an outside organization to study the 10 1/2 miles of Magnolia Avenue and provide improvement suggestions; and (4) mentioned a recent successful collaboration between the Public Works and Public Utilities departments to resolve a road ponding issue related to poor drainage.

Public Works Deputy Director Lee Withers provided information regarding upcoming free events for collection of E-Waste, shredding and bulb/battery, and bulky item drop-off on April 26, 2025, at various City locations.
