BACKGROUND

1. June 12, 2018 – City Council Approved RPU's participation for the use of SoCalWaterSmart website for water rebates.
2. RPU water customers have been utilizing SoCalWaterSmart to apply for and to receive rebates for many different conservation measures such as:
 - a. Turf Removal
 - b. High Efficiency Clothes Washers
 - c. Weather Based Irrigation Controllers

DROUGHT RESPONSE

1. Increase incentive levels for turf removal
2. Continue elevated incentive level for outdoor water use efficiency rebates
3. Offer new water efficiency rebates
4. Double the SoCalWaterSmart budget from \$300,000 per year to \$610,000 per year
5. Align RPU programs and messaging with WMWD as appropriate

TURF REMOVAL PROGRAM - ENHANCEMENTS

1. State-mandated commercial customer non-functional turf must not be irrigated
2. RPU Response:
Increase turf removal incentive from \$3 to \$5 per square foot of turf removed for both residential and commercial customers for RPU Water customers



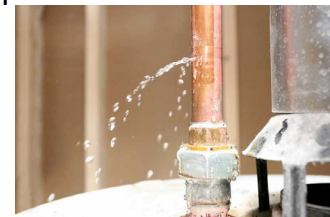

FLOW MONITORING DEVICE PROGRAM - NEW

Residential Flow Monitoring Devices:

1. Flow monitoring devices monitor a home's water use and can help detect leaks.
2. Several varieties available on SoCalWaterSmart
3. RPU Water customers to be eligible for up to \$75 from RPU and \$100 from MWD for approved devices

HOSE BIB IRRIGATION CONTROLLER PROGRAM - NEW

Residential hose bib irrigation controllers:

1. Hose bib timers connect to any hose faucet
2. Used to efficiently irrigate landscaping
3. RPU Water customers to be eligible for up to \$15 from RPU and \$35 from MWD for approved devices

TREE CARE PROGRAM- NEW

Residential Tree Care Program:

1. The US Forest Service recommends the use of soaker hoses and a mulch ring for irrigating trees during water restrictions.
2. This method of irrigation is extremely valuable for those customers who have existing trees which are normally irrigated during turf irrigation
3. For RPU Water customers that provide proof of purchase for a hose bib timer and at least one bag of mulch, RPU will provide them with a free soaker hose at the Customer Resource Center.

RECOMMENDATIONS

That the City Council:

1. Approve the change to the Residential Turf Removal Program, to increase funding from \$3 per square foot of turf to \$5 per square foot of turf, estimated total fiscal impact for FY 2022/23 of \$125,000;
2. Approve the change to the Commercial Turf Removal Program, to increase funding from \$3 per square foot of turf to \$5 per square foot of turf, estimated fiscal impact for FY 2022/23 of \$150,000;
3. Approve the new Residential Flow Monitoring Device Program, estimated fiscal impact for FY 2022/23 of \$25,000;
4. Approve the new Residential Hose Bib Program, estimated fiscal impact for FY 2022/23 of \$10,000; and
5. Approve the purchase of soaker hoses for the Tree Care Program, estimated fiscal impact for FY 2022/23 of \$10,000.
