- Recommend clear instruction for what is expected of the Commission on Disabilities.
- Suggest more items for the Commission on Disabilities from the City Council.
- Suggest more updates and items from City departments related to the Commission on Disabilities goals regarding accessibility, inclusivity, and potential improvements.
- Advise meeting with more Commissions for feedback is critical to making improvements and working more efficiently.
- Consider the timing of many Commission meetings, as the time of the Commission on Disabilities meetings may be preventing reliable attendance from both Commissioners and members of the public.

### *REVIEW AND APPROVE THE REVISED DRAFT OF THE COMMISSION ON DISABILITIES RESOURCE GUIDE*

Following review and discussion, it was motioned by Commissioner Mickelson and seconded by Commissioners Lee, Hennessey, and Pellegrino to approve the draft of the Commission on Disabilities Resource Guide for distribution. Commissioner Lee spoke about a mock interview event he held on May 8th, which included members from the community, school district, and the Riverside Police Department.

Commissioner Mickelson shared that this is likely going to be her last Commission meeting, as she and her family are moving out of Riverside. She mentioned that In-Home Supportive Services (IHSS), despite it being the same program statewide, requires people to reapply and get back on the waiting list if there is a change in address. She also stressed the importance of the Commission on Disabilities, and how the Commission can help people who need assistance but aren't aware of available resources.

### *UPDATES FROM AD HOC COMMITTEES*

Commissioner Tarmo plans to have a meeting in the early fall with members from the Commission on Disabilities, the Commission on Aging, the Commission of the Deaf, and other Boards and Commissions to set up an event at Fairmount Park.

Chair Trimm will share future events to Staff for distribution to fellow Commissioners for their review and gauge interest for Commission participation.
