

RECOMMENDATIONS

That the City Council:

- 1. Award a Professional Services Agreement with CR Associates, of San Diego, CA to complete individualized pedestrian and bicycle safety action plans and customized safe routes to school (SRTS) reports for fifty (50) elementary and middle schools citywide in the amount of \$790,005 for services through June 30, 2026; and
- 2. Authorize the City Manager, or designee, to execute all Professional Services Agreement, including making minor and non-substantive changes and to extend the term, for up to two additional years, subject to the availability of budgeted funds.
