THIS THIRD AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT (“Third Amendment”) is made and entered into this _____ day of _____, 2025, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and ERIC NEVINS, a sole proprietor, doing business as NEVINS PROFESSIONAL INVESTIGATIONS (“Consultant”), California Private Investigator License No. 188286, with respect to the following:

RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement, dated April 27, 2021 (“Agreement”), for Professional Administrative Investigative Services;

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement, dated November 22, 2021 (“First Amendment”);

WHEREAS, the City and Consultant entered into that certain Second Amendment to Professional Consultant Services Agreement, dated October 9, 2024 (“Second Amendment”);

WHEREAS, the Agreement is set to expire June 30, 2025; and

WHEREAS, the City and Consultant desire to increase compensation in the amount of not to exceed One Hundred Thousand Dollars (\$100,000.00), for the extended term of the Agreement, for total compensation in an amount not to exceed Seven Hundred Twenty-Five Thousand Dollars (\$725,000.00).

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

1. Section 3, Compensation/Payment, is hereby amended to increase compensation in the amount of not to exceed One Hundred Thousand Dollars (\$100,000.00), for the extended term of the Agreement, for total compensation in an amount not to exceed Seven Hundred Twenty-Five Thousand Dollars (\$725,000.00).


2. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.
