DISCUSSION CALENDAR

RECOMMEND CITY COUNCIL CONDUCT A PUBLIC HEARING TO AMEND AND EXTEND AN EXISTING FEE LETTER SUPPORTING VARIABLE RATE REFUNDING WATER REVENUE BONDS, ISSUE OF 2011A

Following discussion, it was moved by Board Member Avery and seconded by Board Member Becker to recommend that the City Council (1) conduct a public hearing in consideration to amend and extend an existing Fee Letter supporting the Variable Rate Refunding Water Revenue Bonds, Issue of 2011A, for an additional three years for an estimated cost of \$259,000; (2) adopt a resolution related to the extension of the reimbursement agreement

related to the previously authorized and issued Variable Rate Refunding Water Revenue Bonds, Issue of 2011A authorizing the extension of the existing Fee Letter provided by PNC Bank, National Association; (3) approve the City's Financing Team, as described in staff report; and (4) authorize to the City Manager, the Chief Financial Officer/Treasurer, the Finance Director/Assistant Chief Financial Officer, and the Public Utilities General Manager of the City (or any duly authorized designee of any of such officers) the authority to execute all documents related to this transaction including making minor and non-substantive changes to the final documents necessary to complete the transaction and to pay costs associated with this transaction from the Water Debt Related Fiscal Charges Account. The motion carried unanimously with Board Member Wright absent.

RECOMMEND CITY COUNCIL AMEND MASTER AGREEMENT - REQUEST FOR PROPOSAL 2289 FOR AS-NEEDED ASPHALT AND CONCRETE REPAIR SERVICES FOR WATER SYSTEM MAINTENANCE - RESOLUTION EXEMPTING THE INDIVIDUAL ASSIGNMENTS UNDER THIS AS-NEEDED ASPHALT AND CONCRETE REPAIR SERVICES AGREEMENT

Following discussion, it was moved by Vice Chair Siana and seconded by Board Member Becker to recommend that the City Council (1) approve the first amendment to the Master Agreement with Hardy & Harper, Inc., Lake Forest, from RFP 2289 for as-needed asphalt and concrete repair services for water system maintenance, in a not-to-exceed amount of \$4,000,000 per fiscal year for a term through June 30, 2028, with the option to extend for one additional two-year term; (2) with at least five affirmative votes, adopt a resolution exempting the individual assignments under this as-needed asphalt and concrete repair services agreement from competitive bidding requirements of City Charter Section 1109; (3) with five affirmative votes, authorize the Chief Financial Officer, or his designee, to record a supplemental appropriation in the amount of \$2,500,000 from Water Utility Undesignated Reserves to the Public Utilities Water Field Operations Maintenance/Repair Account, System Expansion Account, and Distribution System Facilities Replacement Account; and (4) authorize the City Manager, or his designee, to execute the first amendment to the Master Agreement with Hardy & Harper, Inc., and any other documents necessary to effectuate the work described in staff report, including making minor and non-substantive changes and to execute the optional two-year extension subject to funding availability, need, and acceptable performance. The motion carried unanimously with Board Member Wright absent.

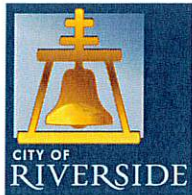
