Mayor Lock Dawson called the meeting to order at 1:00 p.m.

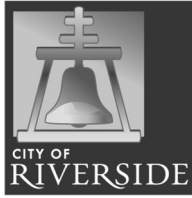
Councilmember Perry gave the invocation and led the Pledge of Allegiance.

RIVERSIDE MUNICIPAL CODE AMENDMENT - FINES AND PENALTIES REGARDING GENERAL NOISE - ORDINANCE ADOPTED

The City Council adopted an ordinance to amend Riverside Municipal Code § 7.35.010, and add Subdivision D, which prohibits any noise disturbance, as defined, which is plainly audible from 25 feet or more from the edge of the property, structure, or unit from which it originates, and allow for increased fine amounts to account for inflation; whereupon the title having been read and further reading waived, Ordinance No. 7703 of the City of Riverside, California, Amending Title 7 of the Riverside Municipal Code by Amending Section 7.15.010 Regarding Fines and Penalties and Section 7.35.010 Regarding General Noise Regulations, was presented and adopted.

BOARD AND COMMISSION RESIGNATIONS

The Mayor and City Council filed the resignations of (1) Brian Baird from the Human Resources Board Citywide seat; (2) Mary S. Berkley from the Museum of Riverside Board Citywide seat; and (3) Steven Cason from the Transportation Board Ward 3 seat.

RIVERSIDE MUNICIPAL CODE AMENDMENT - ESTABLISH AXLE RESTRICTIONS PROHIBITING COMMERCIAL VEHICLES - MADISON/INDIANA/VICTORIA - ORDINANCE INTRODUCED

The City Council approved the Mobility and Infrastructure Committee's recommendation to amend Title 10, Section 10.56.050 of the Riverside Municipal Code to establish an axle restriction prohibiting use by commercial vehicles exceeding three axles and cutting through Madison Street from Indiana to Victoria Avenues; whereupon an ordinance entitled, "An Ordinance of the City of Riverside, California, Amending Section 10.56.050 of the Riverside Municipal Code to Establish Axle Restrictions on Madison Street," was presented and introduced.

RIVERSIDE MUNICIPAL CODE AMENDMENT - CONTINUED USE OF UNPERMITTED AND/OR NONCOMPLYING CONDITIONS - ESTABLISH SAFETY FIRST AMNESTY PROGRAM - ORDINANCE ADOPTED

The City Council adopted an Ordinance amending Title 16 of the Riverside Municipal Code, Buildings and Construction, Chapter 16.04, by adding a new Section 16.04.461 that addresses the Continued Use of Unpermitted and/or Noncomplying Conditions; whereupon the title having been read and further reading waived, Ordinance No. 7704 of the City of Riverside, California, Adding Section 16.04.461 to the Riverside Municipal Code Regarding Continued Use of Unpermitted and/or Noncomplying Conditions, was presented and adopted.

RIVERSIDE MUNICIPAL CODE AMENDMENT - ADMINISTRATIVE PENALTIES FOR VIOLATIONS OF CITY'S FIREWORKS LAWS - ORDINANCE ADOPTED

The City Council adopted an ordinance amending Riverside Municipal Code Chapter 1.18.010 to include a Social Host Liability and use of sUAS Technology for fireworks enforcement; whereupon the title having been read and further reading waived, Ordinance No. 7705 of the City of Riverside, California, Amending Chapter 1.18 of the Riverside Municipal Code Regarding Administrative Penalties for Violations of the City's Fireworks Laws, was presented and adopted.

PROHOUSING INCENTIVE PILOT PROGRAM LOAN AGREEMENTS - AFFORDABLE HOUSING UNITS AND MANAGER UNIT - SUPPLEMENTAL APPROPRIATION - 2524 MULBERRY - 11049 BOGART - RESOLUTION

The City Council (1) approved a Prohousing Incentive Pilot Program Loan Agreement with Mulberry Gardens Family, L.P. for \$1,000,000 in Prohousing Incentive Pilot Program funds for the development of 149 affordable housing units and a manager's unit located at 2524 Mulberry Street in Ward 1 and authorize the City Manager, or designee, to execute the Loan Agreement with Mulberry Gardens Family, L.P., including making minor and non-substantive changes; (2) approved a Prohousing Incentive Pilot Program Loan Agreement with Sunrise at Bogart, L.P. for \$1,440,000 in Prohousing Incentive Pilot Program funds for the development of 22 affordable housing units and a manager's unit located at 11049 Bogart Avenue in Ward 7 and authorize the City Manager, or designee, to execute the Loan Agreement with Sunrise at Bogart L.P, including making minor and non-substantive changes after the Ground Lease has been fully executed between Neighborhood Partnerships Housing Services, Inc., and Sunrise at Bogart, L.P. and recorded against the property located at 11049 Bogart Avenue, Riverside, CA 92505; (3) adopted a resolution authorizing the City Manager, or designee, to submit an application for \$1,440,000 of Prohousing Incentive Program Round 3 grant funds to be used for the development of affordable housing; (4) authorized the City Manager, or designee, to accept and receive Prohousing Incentive Program Round 3 funds and to execute any documents necessary to secure such award and administer the Prohousing Incentive Program Round 3 grant; and (5) authorized the Chief Financial Officer, or designee, to record an increase in revenue and supplemental appropriation in an amount of up to \$1,440,000 in the Grants and Restricted Programs Fund; whereupon, the title having been read and further reading waived, Resolution No. 24229 of the City Council of the City of Riverside, California, Authorizing the Submission of an Application for, and Acceptance of any Funds from, the Prohousing Incentive Program Round Three

2024 HOMEOWNERSHIP SUPERNOFA - HABITAT FOR HUMANITY RIVERSIDE'S AFFORDABLE HOMEOWNERSHIP DEVELOPMENT - 7382/7384 GARDEN - RESOLUTION

The City Council (1) adopted a Resolution authorizing the City of Riverside to submit a CalHome Grant Application to request \$10,000,000 from the State of California Department of Housing and Community Development's 2024 Homeownership Super Notice of Funding Availability (NOFA) to support Habitat for Humanity Riverside's affordable homeownership development of 13 single-family homes with eight accessory dwelling units at 7382 and 7384 Garden Street; (2) authorized the City Manager, or his designee, to sign and execute all documents necessary for the administration of the Cal Home Program grant, including making minor and non-substantive changes; (3) authorized the Chief Financial Officer, or designee, to record an increase in revenue and supplemental appropriation in an amount of up to \$10,000,000 in the HHS Grant Fund; whereupon, the title having been read and further reading waived, Resolution No. 24230 of the City Council of the City of Riverside, California, Approving an Application for Funding and Authorizing the Execution of all Required Documents by the City Manager or Designee for a 2024 Homeownership SuperNOFA offered by the State of California Department of Housing and Community Development, was presented and adopted.

The City Council (1) increased revenues and authorized supplemental appropriations in the amount of \$422,796.61 in the Grants and Special Programs Fund and Various Programs listed in the staff report; and (2) authorized the City Manager, or designee, to execute all documents necessary to receive reimbursement of funds for services performed in cooperation with the task forces listed in the staff report.

ANNUAL ELECTRIC AND WATER UTILITY RATE PLAN UPDATE

The City Council received and ordered filed the annual electric and water utility rate plan update for the results of Fiscal Year 2023-24.

The City Council (1) approved a Design Build Services Agreement for La Colina Substation New Gate and Driveway with Cornerstone Construction Company, Victorville, for a term of one year from date specified in the Notice to Proceed once issued by City, in a not-to-exceed amount of \$228,000; (2) authorized a 15 percent, or \$34,000 change order authority for the contract with Cornerstone Construction Company, Victorville, for Request for Proposal 2383 La Colina Substation New Gate and Driveway Project; and (3) authorized the City Manager, or designee, to execute any documents necessary to effectuate the procurement described in the staff report, as well as the ability to make minor non-substantive changes in alignment with all purchasing policies.

REQUEST FOR PROPOSAL 2340 - AGREEMENT - CYBERSECURITY CONSULTING SERVICES

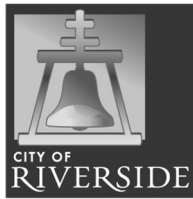

AGREEMENT AMENDMENT - UNDERPASS AGREEMENT - THIRD STREET GRADE SEPARATION - SUPPLEMENTAL APPROPRIATION - RESOLUTION

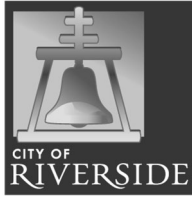

CASE DP-2024-01600 - CITY LANDMARK - MERCANTILE HALL - RESOLUTION - ORDINANCE INTRODUCED - 2931 TWELFTH

Public Hearing was called to consider adopting a Resolution to designate the Mercantile Hall – Orange Valley Masonic Lodge #13, located at 2931 Twelfth Street, as a City Landmark and adopt an Ordinance amending the Zoning Code Map to apply the CR - Cultural Resources Overlay Zone to the subject property. Eight people spoke regarding the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Falcone and seconded by Councilmember Cervantes to (1) determine that Planning Case DP-2024-01600 (Historic Designation), to designate the Mercantile Hall – Orange Valley Masonic Lodge #13 as a City Landmark, is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to Sections 15061(b)(3) (Common Sense Exemption) and 15308 (Actions by Regulatory Agencies for Protection of the Environment), as the proposal will have no significant effect on the environment, identifies the structure as a cultural resource, and preserves the historic character of a cultural resource; (2) approve Planning Case DP-2024-01600 (Historic Designation) based on, and subject to, the Cultural Heritage Board facts for findings outlined in the Cultural Heritage Board staff report; (3) adopt a Resolution designating the Mercantile Hall – Orange Valley Masonic Lodge #13 as a City Landmark; (4) approve the findings for the Zoning Code Map Amendment to apply the CR-Cultural Resources Overlay Zone to the subject property; and (5) introduce an Ordinance to rezone 2931 Twelfth Street from the R-1-7000-Single Family Residential Zone to the R-1-7000-CR – Single Family Residential and Cultural Resources Overlay Zones. The motion carried unanimously.

Whereupon, the title having been read and further reading waived, Resolution No. 24234 of the City Council of the City of Riverside, California, Approving the Application Under Planning Case Number DP-2024-01600 Designating the Mercantile Hall – Orange Valley Masonic Lodge #13 Located at 2931 Twelfth Street, as City Historic Landmark #150, was presented and adopted and an Ordinance entitled “An Ordinance of the City of Riverside, California, Amending the Zoning Map of the City of Riverside Pursuant to Chapter 19.090 of the Riverside Municipal Code by Rezoning Property located at 2931 Twelfth Street from the Single-Family Residential Zone (R-1-7000) to the Cultural Resources Overlay Zone (CR)”, was presented and adopted.
