THIS THIRD AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("Third Amendment") is made and entered into this _____ day of _____, 2024, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and ALTA PLANNING + DESIGN, INC., a California corporation ("Consultant"), with respect to the following:

RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated December 3, 2020 ("Agreement"), for Gage Canal Multi-Purpose Recreational Design Consultant (RFP No. 2032); and

WHEREAS, the City and Consultant entered into that certain First Amendment to Professional Consultant Services Agreement ("First Amendment"), dated December 21, 2021; and

WHEREAS, the City and Consultant entered into that certain Second Amendment to Professional Consultant Services Agreement ("Second Amendment"), dated August 2, 2023; and

WHEREAS, the Agreement expired on December 31, 2023; and

WHEREAS, the City and Consultant desire to extend the term of the Agreement to December 31, 2026, with no additional compensation to Consultant.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

1. Section 2, Term, is hereby amended to extend the term of the Agreement to December 31, 2026.

2. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this Third Amendment, shall remain in full force and effect as if fully set forth herein.
