The Board of Public Utilities excused the absence of Chair Crohn from the December 12, 2022, meeting.

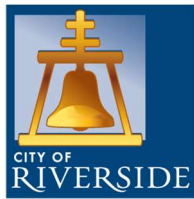
WORK ORDER 2225902 - MONTEEL PLACE WATER MAIN REPLACEMENT PROJECT

WORK ORDER 2223436 - DONALD AVENUE WATER MAIN REPLACEMENT PROJECT

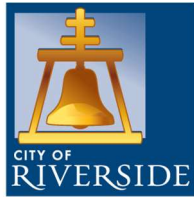
Member Wohlgemuth provided an Ad Hoc Committee on selective fiscal practices update.
